Preface to the New Blueprint For Humanity

[Originally written for the American version, 25 March 2023.]

The Government Solution

Why this is needed:

A reality of which the majority of people in Canada are unaware is that all the organizations we call government are, in fact, corporations "in the business of government." The 1759 "Corporation Sole" that eventually became the colony called Dominion of Canada began with the "Province of Quebec" and gradually amalgamated other regions to form the "Province of Canada."

In 1893, a law enacted by the British Parliament officially ended monarchic rule of the British colonies upon the death of Queen Victoria. Then, a 1931 Statute of Westminster officially ended colonial status of Canada and directed that each province was to establish an independent government, and then decide together whether to create a confederation of equal states. However, power groups in this country withheld that information and both Ottawa and the provinces operated as though Canada remained a Dominion under British rule.

Pierre Elliot Trudeau, as *de facto* Prime Minister, brought from England a copy, not the original, of the Letters Patent known as the British North America Act. Parliament then fraudulently called the BNA Act a constitution (it constitutes nothing) and all provinces except Quebec ratified it. Since it was not ratified by all provinces, it is not valid under their own rules.

The Meech Lake and Charlottetown Accords that were intended to amend the Constitution Act and make it valid were not accepted by the people. Therefore, there is no Constitution of Canada.

What does all this mean? Canada has no valid governance. None. No valid constitution and therefore no valid parliament or legislatures by and for the people, but only by and for corporations found on the stock exchanges and beholden to the parent corporation known as The Crown and its subsidiary, the United Nations.

The fact is that Canada does not have a real government. Neither does it have its own law, currency, organic constitution, bill of rights, central bank, treasury, tax and revenue division, sovereignty, military, intelligence agencies, or even voting machines. The government has failed the Canadian people in all services, care, and security and has allowed a foreign-based coup to take place under the noses and beyond the understanding of most of the people.

We cannot and must not blame politicians alone for all of these ills, as many of them have been misled. The people themselves are as much responsible for the mess of the current system, due to our own lack of participation, lack of responsibility, and desire to pass the blame onto others.

The operation of the acting governments has failed us all, and it is time to rebuild our country for the future: a future filled with hope, unity, and optimism.

- Dissolve all political parties and all lobbyists and their organizations. Create actual
 governing bodies, people's congresses, with no affiliated former groups of the old
 system, but with members that will only work solely for the benefit of the people of
 Canada.
- 2. Allow no lawyers, doctors, military officers, venture-capital people, or members of banking, intelligence agencies, conglomerates, large corporations, think tanks, and old-wealth families to hold office. We need a fresh approach altogether, as those groups all failed us in the past. Nevertheless, it may be possible to reintegrate them on an individual basis when they have proven their trustworthiness to the people.
- 3. Remove the governor general and lieutenant governor positions and the Privy Council as they are a part of the fraud that has been perpetrated, and remove the fictional power of the British royal family. Disconnect from all political think tanks, lobbyists, and corporate interests. Decision-making should be done by the people themselves, as this will encourage growth in all people.
- 4. Remove all funds and connections to acronym-based organizations that are not actually part of Canada, like NATO, the UN, the WHO, the WTO, the WEF, etc.
- **5.** Dissolve all transhuman agendas and research, all racist and division-promoting programs, and all policies and programs that have a genocidal effect, and instead put effort into the health and harmony of the Canadian people.
- **6.** Create a real Constitution, a new Canadian banking system and currency in physical form rather than digital, and new administrative departments operating for useful purpose.
- 7. Remove all policies of the past that worked against the people and the interests of the country. For example, national security acts, emergency acts, non-compete acts, and many others.
- 8. Restore all administrative services to be carried out by the actual governing bodies; no private contractors, non-governmental organizations (NGO's), or non-governmental agencies (NGA's).
- 9. Cancel all global trade deals and renegotiate them in a way that it is a straight deal for trade items that we do not yet produce in Canada. No political, strategic, stipulative, or weapons-based additions to trade deals will be allowed. Implement a policy whereby Canada becomes self-sufficient in all categories of trade, where possible.
- **10**.Remove all corporate aid, foundations, and foreign funding programs and use the funds for the benefit of the Canadian people only.
- **11.**Quickly implement food, water, and shelter policy groups designed to tackle the shortages that the people are presently experiencing.
- 12. Elections and selections will be held in transparency, with all officials gaining office based on their ability to do the job, not on patronage or on how much money is spent or raised. End the wasteful donations programs that all politicians receive and terminate the fake and empty promises that mean nothing. Public office will be treated like any other job, not some over-privileged superstar with a meaningless title. A lottery-in vote-out system of selection may be implemented in place of elections that tend to attract narcissistic personalities.

- 13.Create Canadian law based on RITA: natural or universal law. Complete a full review of all the laws; those that are deemed not beneficial for the people are to be removed and replaced with something better, if required. Or, given the mishmash of contradictory, deceptive, and oppressive statutes, bylaws, mandates, and other edicts of the corporations that have exerted power and influence under the fraudulent claim to divine right to rule, it may prove simplest to repeal all past laws and create a simple and useful set of coherent laws that serve as the basis of lawful and harmonious functioning of governing bodies, organizations of every kind, and people in Canada.
- **14.**The regions currently known as provinces may choose to establish themselves as independent countries as specified in the Statute of Westminster of 1931, and may also choose to join each other as a confederation of independent countries allied in common interests such as defence.
- **15.**Standardize all laws and departments across all the regions and provinces / independent territories, whereby a driver's card and other identification is valid across the country or confederation.
- 16.Reassemble an actual Canadian military and militia defence system and true law-enforcement organizations under Canada-only dictates, to protect and serve the Canadian people. Under an Emergency War Powers Act, issue orders to arrest all the top-end criminals in one sweep. The arrested will be installed into the Full Disclaimer for Full Disclosure Solution. Note that such an emergency act created by a congress of, by, and for the people would be valid; on the other hand, the Emergency Act of the Ottawa parliament is invalid as that parliament has no real authority.

To achieve all of this, we may need to lock down incoming and outgoing travel for a short period of time, until some of the solutions—notably Solution 16—are completed sufficiently to allow the country to operate without undue disturbance to the people.

Who gains:

All departments, as they have a clear direction going forward because they are no longer hamstrung by policy makers who were not truly elected by we the people. The administrators, as they have a clear definition of how to operate, act, and deliver useful services.

The potential to go to war will be drastically reduced, making people feel safer.

Those in public office would benefit greatly, as they are no longer expected to hold the burden of the country and its entire populace, as it now becomes a shared responsibility.

The country, regions, and communities will be better off financially, with an end to the government debt-accumulation policies, bank and oligarch overreach, and taxation practices of the past, which fulfilled only the wishes of corporate and vested-interest groups.

Self-sufficiency in terms of trade reduces the deficits to zero and will bring a surplus, which will benefit the people and the country.

Who benefits:

The people benefit the most, as they now have a government they can trust. The people will have more time and resources directed towards them by the governing bodies. The people will have more money in their pockets, aiding the economy. The people will feel that they really belong to not only the country but to the planet as well. This raises the levels of pride in undertaking this task, in terms of their involvement in governance, which in turn encourages participation by more of the people in a shared personal and collective responsibility.

Ending secrecy and underhanded practices brings everything in line with a transparent, fair, and equal-opportunity form of governance. It will end the lie of Canada's being a praiseworthy civilization spoken only in words but not evidenced in reality. With this solution and many more in this Blueprint, Canada will earn a reputation for truth, honour, and integrity.

The world and its varying races will benefit, as we will be acting as a far more adultbased species and shed the kindergarten attitudes we currently exhibit: an advanced civilization that can reach out into the stars as a harmonic addition to the cosmos, and indeed as an example of how to be, act, and engage.

The Canadian Overhaul Solution

Why this is needed:

Early in the 20th century, the political and merchant elites of various countries privately ceded commercial sovereignty to the global financial system based primarily in the United States through the registration of trust structures and commercial trading entities. This created corporate bodies associated with demographically and politically defined regions possessing the appearance of legitimate legislative bodies, but usurping the rights and authority of sovereign legislative bodies in defiance of the will of the people and founding constitutions.

Since 1933 all nations were quietly set up as corporate trusts, registered in the state of Delaware through the SEC system. Universal Commercial Code (UCC) applies to all nations and their "employees" when treated as corporations and registered commercial "vessels." International Law ensures key institutions such as private banks are virtually a law unto themselves, and many "government" services have been privatized into privately owned trusts, providing the illusion of public services. Some examples are prison, transportation, energy, legal, defence, and education systems.

The current system is not a positive, life-affirming system, but a system of harvesting and control. It is being run by self-serving entities that harvest Canada and its people of all our wealth.

- 1. We the people will form the sovereign country of Canada, a confederation of sovereign states that are of equal rights, with equal rights available to all the people, and which includes all the land and all the waterways of the former Dominion of Canada, Newfoundland & Labrador, and Nunavut. The country of Canada will demonstrate all the key elements of what constitutes a valid country, irrespective of whether its validity is recognized by any external body or by other countries. We will also review all treaties and claims of the indigenous peoples who need to be respected and included as equals in the new country of Canada. We reject all law and definition of law that requires sovereignty as a state or territory to be recognized by any other country or by any nation. We the people also reject the use of the corporation of CANADA as a body politic and governing body, which was declared under false premises that render such claim null and void.
- 2. Dissolve any and all corporations with the word Federal or National in them, as well as all operating under capitalized names including and not limited to CANADA and ONTARIO, as all such organizations are, in fact, private corporations, whether traded on stock exchanges or privately owned.
- **3.** Create true, independent governing bodies to replace the provincial and territorial corporations including and not limited to ONTARIO, PROVINCE OF and their counterparts at the regional level including and not limited to county, township, and

- municipal corporations. Eliminate any form of labeled government, be it Republic, Democracy, or any other -ism ideology.
- **4.** Create true Constitutions suitable for this time to govern the operation of each and every governing body in alignment with Universal law so that all governing bodies operate solely on the premise of acting at all times for and on behalf of all men and women within their respective jurisdiction, and throughout the planet where applicable.

The basics of Universal Law are:

- a. All are equal under the law and no one is above the law.
- b. All law is measured that all may learn, remember and comprehend it.
- c. All law is standard that it may always be applied the same.
- d. All laws are simple & easily publicly available.
- e. All laws are respectful of gender, race, religion or creed.
- f. All laws are reasonable and no law demands unreasonable or impossible acts.
- g. All laws are logical, consistent and do not require illogical, contradictory or confusing behavior.
- h. All laws are moral, loyal, merciful and remedial so as not to impose punitive measures without first the opportunity to remedy an error.
- i. All laws are merciful so that no law encourages cruel and barbarous acts of vengeance.
- **5.** Flexibility must be built into Constitutions to allow for adjustments necessitated when theory meets reality.
- **6.** As individual independent states, the former provinces and territories have the ability to return to a system of direct trade without tax burden or interference from corporations. This would encourage greater self-sufficiency in all regions, and increase creation of businesses that meet Canadians' needs for employment and for goods and services while also enabling each region to barter for what cannot be produced locally.
- 7. The individual independent states have the authority to create a confederation of equals without legislative power to administer systems of mutual benefit including and not limited to creation of a non-digital and non-programmable confederate currency of specified definition and value accepted across all states to supplement the non-digital and non-programmable currencies of communities, regions, and independent states; a united defence force to supplement those of communities, regions, and independent states; and to facilitate cooperation among law enforcement agencies of the independent states, regions, and communities as needed.
 - a. Note that a non-digital and non-programmable world currency of specified definition and value may be accepted if such is created and agreed upon by all countries, states, regions, and communities through a transparent worldwide referendum.
 - b. Foreign and or corporate control of currency and other exchange systems; banking and financial institutions and systems; governing and administrative systems; policies and laws; lands and resources; and

- peoples of the territory formerly called the Dominion of Canada is prohibited.
- c. Programmable currency is prohibited.
- d. Compound interest is prohibited.
- e. Usury, here defined as interest rates above 5% of principal of the loan, is prohibited.
- f. Barter of goods and or services is accepted as a valid and non-taxable means of exchange.
- **8.** Ensure oversight, transparency, and accountability of all governing bodies, administrative bodies, departments, agencies, courts, law enforcement, and military organizations and all personnel thereof.
- **9.** Shut down all intelligence agencies of the old system and create new ones with just three departments: foreign, domestic, and cyber threats, that cooperate with their counterparts in other jurisdictions and with law enforcement and People's Congresses.
- **10.**A full withdrawal of any connection to United Nations, NATO, WHO, CDC, WTO, WEF, The Crown, and all other organizations that are siphoning money out of every country at the behest of the old system of control.
- 11. Sever the connection to the Bank of International Settlements, IMF, World Bank, Federal Reserve banknote printing system, and the Vatican Bank, and shut down the Treasury and Finance departments connected to those foreign organizations. Remove Canada Revenue Agency and its provincial, territorial, regional, and community counterparts as they are foreign imposters harvesting Canada of funds. Create new and transparent Treasuries and Revenue departments with administrative but not legislative powers.
- **12.** Immediate cease and desist of funneling taxpayers' money into black-budget accounts. Seize all such accounts and return the money to the relevant governing bodies, and subsequently to the people via tax breaks or direct refunds.
- **13.** Immediate cease and desist of funneling taxpayers' money into fake aid programs. Seize all the accounts and return the money to the relevant governing bodies, and subsequently to the people via tax breaks or direct refunds.
- **14.** Immediate cease and desist of all drug and other trafficking implemented by intelligence agencies, policing agencies, child protection agencies, medical establishments, and others. Locate the accounts, confiscate them, and return the funds to the relevant governing bodies to go toward healthcare.
- **15.** Immediate cease and desist of all genetic, psychotronic, bio-warfare, mind-control, cloning, hybridization, abductions, chemtrails, vaccines, sterilization programs, transhumanist agendas, and all other exotic forms of weaponry harmful to us and the planet.
- **16.** Set up a multi-disciplined assessment team including some members of the alt media to analyze all technology available as to whether it is beneficial to humanity or not; if not, it is to be destroyed.
- 17. Set up a multi-disciplined assessment team including some members of the alt media to analyze all underground bases for full disclosure of their intent and purposes, and to discern whether from a financial or ethical point of view these are

- cost effective and beneficial for the public or the planet; they are to be dealt with accordingly.
- **18.** Set up a multi-disciplined team to liaise with all other countries threatened by the rogue elements, and provide support and logistics for them to complete their clean-up process quicker.
- **19.** Effect a steady release of the new technology that has been denied to the people, providing that technology is deemed to be of benefit by the assessment team.
- **20.** Place all those arrested into the Full Disclaimer for Full Disclosure Solution.

Who gains:

The people of Canada will gain as a result of these changes. Instead of financial harvesting in the guise of foreign aid and other fake programs, Canada will be focused on its own people and concerns. Canadians will no longer be impoverished through taxes, fines, licences, and inflation; their hard work and time invested will be rewarded by richer, more fulfilling lives.

Who benefits:

All Canadians will benefit from these changes with more freedom, a reduced and more efficient system of governance with less bureaucracy and control, and a focus on solutions that serve the people.

The Countries Solution

Why this is needed:

For the last 500 years the world has been moved towards a system of pauperism, ignorance, depopulation, barbarism, and debt slavery. For the survival of our species, it is imperative to create a new system that elevates and equalizes the condition of men and women in all countries of the world.

"One looks towards universal war; the other towards universal peace." – Henry C. Carey, Harmony of Interests, 1851.

Solution:

A. All countries must be made sovereign, and to do so the old system must first be deconstructed.

- 1. Cancel all treaties, pacts, trade deals, weapons deals, UN and NATO directives.
- 2. Old pacts or treaties tying countries to the more powerful states must be removed.
- 3. Cancel all global memberships; they did not serve any country well.
- 4. Remove all rogue elements such as CIA, CSIS, GCHQ, etc.
- 5. Eliminate all loans to all countries initiated by the old system.
- **6**. Remove all politicians that were put in place at the request of agencies and the old system.
- **B.** Sovereignty can only be attained with self-sufficiency, and to do so:
 - 1. Every country or state must analyze all commodities they import and work towards self-sufficiency.
 - 2. Trade deals can be made only with other countries for items each country needs, with no clauses or stipulations such as demands to change laws or policies, just a straight buyer and seller deal.
 - 3. No hoarding of commodities; all major commodities are to be shared equally amongst all countries.
 - 4. Corporations or external countries that think they own mineral resources or lands are to be bought out, and the natural resources can be returned for development by the people. All those who acquired businesses or land, harvesting a country's assets, did so out of the Global Trust and also did so by leveraging the assets. That means the Global Trust owns all the assets; therefore, buying out and returning these resources to the people should not come at a great cost.
 - **5.** The Provinces and Territories of Canada can become sovereign states, as was intended by the Statute of Westminster, at which point the population can vote to decide to form a confederation of equal states with an agreed upon constitution.
- **C.** Once countries are sovereign, a vote can be conducted to adopt the Ucadia model of global and regional unions founded on the True Rule of Law as defined in the Ucadia

Covenant of One Heaven with the consent of the people. This Covenant is founded on the truth that a unifying singular force, unique collective awareness, the one true and absolute Divine Creator of all existence, bestowed in trust to all humanity certain irrevocable rights and obligations in perpetual remembrance as trustees for all life on planet Earth.

Within this system, each Union of countries will have 11 primary objectives:

- 1. To design, nurture and implement sustainable systems of improving health, learning, well-being, sanitation, industry, clean environment, law and order, and prosperity within communities, towns, villages, cities, and countries across the union.
- 2. To secure, protect, and defend the union, seeking peaceful, amicable, and harmonious relations, treaties, and alliances with all unions, bodies, and countries that respect the Golden Rule of Law, justice, and fair process, and to pursue, prosecute, and bring to justice any individual or body that seeks to abuse, trespass, or injure the union or any countries or regions within the union.
- 3. To protect, prosecute, and enforce the laws of the union and to seek mutual recognition of such jurisdictional rights with foreign bodies and courts that respect and operate within the Golden Rule of Law, justice, and fair process, and to ensure that the courts of the union are recognized as the first, primary, and original jurisdiction for the resolution of all matters of dispute.
- 4. To support, reward, and grow innovation, employment, and intellectual property, capacity, productivity, and profitability among businesses and companies of the union
- 5. To teach, encourage, and support growing respect and trust in the institutions of the union, and to ensure all regions within the union are represented by elected and living members of the regions. Ensure the formation of a permanent Parliament or Congress as a valid body politic with associated authority, powers and lawful controls. All officials must be elected, or selected through a lottery-in vote-out system. There will be no divine right or bloodline inheritance of any official positions or titles.
- **6.** To select, support, and honour the commission of key officers within the union, and to ensure the fiduciary life of all ministers and officers of the union are conducted according to the discipline and spirit of such sacred commissions.
- 7. To teach and encourage existing networks of people that share the same common values as a Ucadia union to consider becoming a member of the union.
- 8. To support and operate the government of the union holding all administrative rights, powers, faculties, capacities, uses, titles, and authorities related to all valid Ucadia union regions and countries.
- **9**. To administer and facilitate all lawful transactions and communications for the proper financial management of the union.
- 10. To establish, maintain, and strengthen amicable, harmonious, and respectful relations with all bodies politic, societies, and entities within and without the union that respect the Rule of Law; and to assist, support, aid, nurture, respect, honour, and help the people of each union using the full resources and powers of the union.

11.To protect, defend, support, and assist in times of need the people in all regions of the union and to ensure the maintenance, strengthening, and improvement of the quality of life for all under true dignity, mercy, honesty, harmony, and fair justice.

Who gains:

All the people of the world will gain when living under a complete system for sustainable prosperity.

Who benefits:

All the people of the world will benefit equally as each country within each union restores full sovereignty and all countries are treated as equals.

Military conflicts will decrease as wealth distribution becomes more balanced between nations. This will free up immense military budgets for positive investments. There are many more benefits to society that will flow from this solution.

The Global Shortages Solution

Why this is needed:

Life has never been fair on this planet, with 10% living like kings in comparison to the rest of the world. Food shortages are a global disgrace, for we produce enough to feed three planets each year. 1.3 billion people with no electricity or power is tragic in this modern age and is suggestive of a deliberate blocking of human development. 2.3 billion people with no access to clean sanitation is also suggestive of people being deliberately held back and is not conducive to an advanced civilization. More than 1.8 billion people worldwide lack adequate housing. Every year, 2 million people are forcibly evicted, many more are threatened with evictions, and some 150 million people worldwide are homeless.

Adequate housing is a human right enshrined in international human rights law. Everyone should have access to the five basics in life—clean water/sanitation, food, energy, clothing, and shelter—and eliminating the shortages should be at the top of the list for every country. A basic lack of caring, planning, and will has created this intolerable situation, and we all must strive to correct this overarching problem together. For the species to advance we should all have the basic necessities, which naturally curtails crime rates, disease, class systems, and environmental issues. Increasing care for others can eliminate the suffering from hunger and lack of shelter.

- 1. Use all large military planes and vehicles to move to wherever needed the means to ensure all people have the five basics in life. That can improve their standard of living to be on a par with the western world, including those in poor districts of the western world. This should take 2 to 5 years with all militaries cooperating.
- 2. Create a map of places to prioritize, where help is needed immediately. Create the three help stages that are needed, marked in red, orange, and green on the map. Designate a management group in each country and send military assistance there. Create jobs for people by designating positions responsible for checking what is needed in a given area, taking care and teaching, providing mental/emotional support, and acting as an intermediary between people and the army.
- 3. Consider relocating some people to other more favorable places where it will be easier to create healthier conditions for them; for example, abandoned cities with abandoned buildings that can be adapted to life.
- 4. Create video workshops for the poor in the community to teach them how to better manage and cope in their places of residence.
- **5.** Involve scientists and university students in a commitment to improving living conditions by creating and suggesting solutions, whether old technologies or new, for such needs as water purification and electricity generation.
- **6.** Create a website with a form to be filled in to report cases that need assistance. Create a web team of people who will be monitoring the websites for each location.

7. Speak out loud in the media about what is really happening in other parts of the world, so that awareness in rich countries increases. No more selective and fear-based media. Instead, presenting solutions will result in more sharing and a change in the collective consciousness of how much is really needed.

Who gains:

The military by helping to clear their karma and giving cause for pride in providing a useful service to benefit and protect the people.

People who need new, better, and more rewarding jobs, as well as potential for new jobs in a new country, which allows for better integration and increases their awareness and knowledge base.

Fixing poverty once and for all will reduce and eventually eliminate the program of the haves and have nots.

Humanity, as empathy and awareness increases when we all know what is happening on our planet, and as the completion of this project raises everyone up into a better frequency, heals relationships of countries and peoples, and gives everyone the opportunity to live and thrive, not just exist day by day.

Who benefits:

Those with mental problems, the disabled, and the elderly who have been left to themselves; poorer countries; those who live in badly adapted regions of the world; and war and disaster victims. This solution recognizes that all people are important, and that none are more special or privileged than anyone else.

The I.T. Solution

Why this is needed:

Corporations monopolize industry and technology. Certain corporations have been able to buy or steal any new innovations, either suppressing them or putting them on the market before other companies could compete. Some of these companies were set up by agencies such as the CIA, DARPA, and NSA to collect private/personal data for spying and profiling purposes by offering products and services under the guise of free trendy devices and software to connect us all together. All of these companies have built back doors into all software programs and devices available on the market today.

The industrial policy of planned obsolescence forces consumers to replace malfunctioning products frequently, while the lack of standard parts makes repairs difficult or impossible. Indeed, some companies bind consumers to contracts that deny buyers the right to repair their devices.

The internet has been flooded with advertising as well as scams and various methods of harvesting data. Further, the Dark Web is primarily used for the sale of drugs, child pornography, and other illegal products and services, and thus contributes to many crimes.

- 1. Repurpose the corporations and agency companies that have controlled technology and the internet, such as Microsoft, Google, IBM, Facebook, Twitter/X, etc., and split them into smaller enterprises.
- 2. Ill-gotten gains of the repurposed companies are to be confiscated to fund the restructuring and also new startups run by innovators.
- 3. Require all computers, phones, and other devices to be built without back doors in the hardware, firmware, and software; without tracking, spying, profiling, and other data-harvesting capability, as well as without advertising.
- 4. Anti-virus software must be installed on all computerized devices sold.
- **5.** Make data mining, profiling, tracking, and spying illegal, as well as the sale of personal data.
- **6.** Provide an option for users to share personal information, if they choose to, by stating clearly and explicitly that they wish to share personal information, where they wish to share it, with whom, and which specific information is to be shared.
- 7. Provide an option for users to explicitly accept or remove advertising.
- 8. Ensure all emails and ISP's (Internet Service Providers) are secure and free from hacking, spying, data mining, malware, malvertising, and other malicious activity.
- 9. Remove all child pornography from the Dark Web and internet, as well as all sites designed for the sale of illegal goods and/or services, including but not limited to drugs, bio-weapons, and adrenochrome.
- **10**.Create a team that focuses totally against hackers and other cheats, and on monitoring and cleaning of the Dark Web, working with governing bodies, the Cyber Agency, Military, and other agencies as appropriate.

- a) Note that the Dark Web cannot be deleted without interfering with the privacy of individuals. However, it can be monitored and illegal content removed in order to stop illegal activity.
- 11.End censorship of the public.
- 12.Standardize all aspects of computing, including a unified operating system that may be offered in three modes: minimal, standard, and pro, and at low, medium, and higher price respectively, with equal quality but more features on the higher-grade items. Different industries that make partially computerized products (cars, home appliances, elevators, sensors) must build standard systems appropriate to the type of device they manufacture, such that all similar devices have standard parts.
- **13**.Companies must standardize parts, sold in a standard format, so that all accessories can be used on all brands and items of the same kind, each type of device having the same power adapter, ports, sizes, settings, etc. for each of the high, medium, and low-priced models.
- **14.**Products must be easy to repair and buyers must have the right to repair them. All parts must be standard and easily accessible.
- **15.**Products must be made with materials that are not harmful to users, and that can be safely recycled or destroyed at the end of useful life rather than dumped in landfills.
- **16**.Clarity about how long devices and software will last is required.
- 17. Any products that, by their nature, have transparent obsolescence—that is, a known and clearly labelled useful lifespan, after which they may not be supported or may break down—must be replaced by the manufacturer if they break down before that end-of-use date.
- **18**.End all subscription-only programs for products such as Microsoft software, PDF subscriptions, advanced email subscriptions, etc. Allow consumers to buy a product up front with no extra add-ons, forced support costs, or other costs not directly related to the product.
- **19.**Products may be sold with an option to pay in installments, so users can finance bigger purchases without resorting to a bank loan or use of a credit card.
- **20**.Replacement cost before failure is built into product costs, and options for support can be built-in or purchased.
- **21**.Re-assess encryption methods and digital security certificates. Enable end-to-end encryption with the use of private end-user keys.

Who gains:

The public gains by less waste of money on substandard merchandise and devices that cannot be repaired, and by increased useful life of products. Less waste from products, less need for landfills, less polluting of water and landscapes, all of which aids the environment.

Creative individuals and businesses gain opportunity to contribute better products and services. Many of the people in the companies that formerly monopolized IT and industry can retain jobs and incomes when the corporations are restructured, and they will learn better ways of operating.

Who benefits:

Professionals who wish to maximize IT potential have an opportunity to do so. End users enjoy a cleaner internet and safer web interactions. Children and society in general are safer when the Dark Web and illegal dealings are curtailed.

The Law Solution

Why this is needed:

We live in a time where there is no Law, there is instead the appearance or the colour of Law. We have laws that are secret, unclear mandates, and rules that cannot be applied. We have a private BAR Guild system (British Accreditation Registry) that has monetized crime, contractors as agents acting as judges under public oath whilst considering themselves under a higher secret oath, all of which creates an unequal system where "elites" are above the law and people are considered chattel, property, and things. There can be no justice in this system, there can be no honour or Rule of Law in this system; hence, there is no Law.

Solution:

- 1. End all legalese, which is the language of babble and deception.
- 2. End all Law associations like the BAR system, which is a private Crown-based club and a "rules for one and not for others" system.
- 3. Retrain all legal professionals under the natural Universal Law system.
- 4. Have all courts, judges, and operatives adopt and adapt to the new system that does not function as a private maritime collection service on behalf of the few, or if necessary create an entirely new set of courts and officials based on the new system of True Rule of Law.

How to restore the True Rule of Law:

In the Vedas, the law behind existence is RITA, and it is said that to tamper with it will prove deadly. The whole of creation is called *sat*, which has an inbuilt Cosmic/Divine law, RITA. If *sat* (existence) is a fact, then the value which we realize out of it is RITA (Cosmic/Divine Law). When we realize RITA, the value of the whole of creation, we are humbled and naturally become more caring towards the universe. The entire universe supports our sustenance and the whole of creation toils for our existence. This awareness infuses immense gratitude in our hearts.

The word RITA has no equivalent in English but can loosely be translated as the cosmic order in the Universe, the Divine Law governing the Universe. The word RITA is derived from the root word r which means dynamism, vibrancy, seasoning, and belongingness. RITA governs the moral aspect of Man. The line between good or evil runs through every human heart; we have to choose on which side of that line we stand. We can choose RITA, Cosmic/Divine Law, or not; this is the choice in every moment and every decision we make that creates the society we live in. We get what we choose, and by choice consent to, and the Universe echoes back what we transmit. RITA manifests as The True Rule of Law under The Golden Rule: that all are equal under the law and no one can be above the law.

We can restore RITA and The True Rule of Law if we restore the Four Pillars to The Golden Rule of Law: Equality, Measure, Standard, and Voice:

- Equality: All are equal under the law and no one is above the law.
- Measure: All law is measured (concise) so that all may learn and know it.
- Standard: All law is standard so that it may always be applied the same.
- Voice: All law is spoken, as it is the spirit of the word that carries authority, and all
 action under law is by word of mouth and writing is for memory and never law in
 effect.

To restore the True Rules of Law we must also restore Sacred Trust through restoring the idea of true oaths and vows and the notion of restoring Sacred Office, and by restoring the principle that promises must be kept, that one's word is one's bond, and that what people say is what they mean. If people have no trust between one another, and if people do not have confidence with one another, then the True Rule of Law will continue to decline and remain open to control and manipulation. To restore True Rule of Law we must create a justice system founded on clean hands, good faith, and impartiality so law is always applied without prejudice, bias, or hidden interests, and we must ensure that the system is simple enough for all to understand and is available for all to learn and refer to. A new model is needed to replace the existing model if we are to choose RITA and restore the True Rule of Law. This model can be found in Ucadia, a complete model created by Frank O'Collins.

Ucadia contains 22 Canons of Law, which when studied and adopted provide a path to competence and the restoration of Law. Ucadia also contains charters; a new monetary system; concepts that provide the structure to form communities based on trust; and a justice system founded on clean hands, good faith, and impartiality so it is always applied without prejudice, bias, or hidden interests. In order to adopt Ucadia as a solution, the Canons will need to be taught to individuals willing to become competent, for it is only when individuals are willing to take self-responsibility to choose to live a life according to RITA (Cosmic/Divine Law), learn, and live honourably, can RITA and True Rule of Law be restored in our society.

Who gains:

Everyone gains from the restoration of the True Rules of Law, due process, and justice, where all are treated equally under the Law.

Who benefits:

Everyone benefits from living in societies founded on the True Rules of Law.

The Oil and Transport Solution

Why this is needed:

Energy is one of the five essential needs for life, along with food, water, clothing, and shelter. Energy is different because it enables an expansion of an individual's existence.

Oil and its products have the most flexibility because they can be easily and costeffectively transported and stored, and have a wide range of applications. Energy usage underpins economic activity, which is essential in the development of poorer nations, enabling their populations to extend their access to other regions and products. This advancement also requires access to vehicles of transportation and other technologies that use oil or oil products.

Oil is not a fossil fuel, it is abiotically produced by the Earth and sufficiently abundant to meet the needs of the entire planet. Price and distribution of oil and its transportation products are artificially controlled by cartels, which will need to be removed. The Earth's resources belong to all the beings of the planet, not just to the location of those resources or to those who have procured access to the resources.

- 1. Discover and develop alternative technologies like water fuel cells and liquefied natural gas (LNG) for transportation applications. This effort includes release of any efficiency improvements previously hidden, or patents occulted under the excuse of "National Security." These changes may expand our understanding of science and the source of energy. Transportation is a large sector of the economy, and offers the economic opportunity for development of new technologies and efficiency improvements.
- 2. Countries should be encouraged to develop energy sovereignty and develop selfsufficiency in their energy supplies.
- 3. Countries can still import oil to meet any deficiency of internal supply. Oil must be shared globally through straight transactions free of coercive trade deals and cartel controls that hold the importing country hostage. The broadening of the market provides consistent income to oil companies, while the developed countries shift to electric transportation or other alternative technologies. Increase of consumption by less-developed countries and simultaneous decrease in developed countries enables oil companies to maintain revenues to recover their investments and fund pensions.
- 4. Switching to other technologies creates an inventory of used cars, which can be shipped to the developing countries for their use. The military can assist with these shipments.
- 5. Remove oil pricing from world commodity markets and allow the oil companies to price at delivery, with appropriate profit no greater than 10%. Should the oil companies not agree, the military can sequester all oil companies and privatize them in the name of the people, with oversight by the people and their governing bodies.

- **6.** Prioritize the development of technologies needed for trucks, train engines, and ships to enable the bulk transportation of goods between regions.
- 7. Build refineries in oil-producing regions rather than use pipelines or other means to send crude oil to other countries, only to buy back the refined product or buy foreign oil instead of domestic.

Who gains:

Underdeveloped countries gain with access to affordable energy and transportation vehicles. Oil companies can maintain profits and demand for their production to enable the recovery of their investments. Developed countries will gain as they expand services to the less-developed countries, with increasing demand for other products and services.

Who benefits:

The people, who can switch to new transportation technologies.

The Earth, as pollution can be reduced. This is part of the restoration effort.

The Military and Defence Industry Solution

Why this is needed:

What we're really talking about here is everything under the aegis of the DND (Department of National Defence), which operates a web of waste and corruption that extends to corporations, intelligence agencies, and illicit practices worldwide. The military is a disaster and the officers and bureaucrats answer to masters that have no interest in the common people of this world. The military structure includes various departments and commands that seem to do their own thing with no oversight and/or under a veil of secrecy. Every aspect of the DND, the MIC (military industrial complex), and by extension the military, is corrupted and no longer working, all whilst being funded using our tax dollars. It's time for that money to be returned to us, to be used for and by the people.

- 1. Use the DND and its resources to fix what they have broken and to work for and with humanity, instead of against it. Care will be exercised with how the financial aspects and allocations of this situation are handled. One suggestion is to scrap their whole budget in its current form and start again. Repatriate black-budget funds and MIC contracts to the extent practicable, then close those pipelines permanently. We can take away the money until they can propose projects that will benefit humanity and clean up the messes they have left.
- 2. Remove the Neohawks, the Zionist lobbyists, warmongers, and the MIC harvesting agents and the many other cogs in the anti-human war machine.
- 3. Cancel all contracts and remove any form of non-compete legislation entirely.
- **4.** Use the DND budget to commandeer all ships, planes, and other transport equipment and redirect their efforts towards providing transport for food, water, clothing, housing, and energy to the vast number of people around the world and within the country who lack those things.
- **5.** Rebuild the towns, cities, and infrastructures smashed into oblivion by bombs dropped from above or from afar.
- **6.** Transmute the military and associated defence contractors into a force that works for the benefit of humanity, operating in peace, not war. This will accelerate the healing of the planet and the people. It will also aid the rehabilitation program, which will be extensive, in allowing individuals to work off any accrued karma.
- **7.** Recycle the endless array of weapons-based hardware and put the scrap to good use elsewhere.
- 8. We know that all nuclear weapons are non-operational and have been for a long time; it is time to end the fear. We will decommission and ultimately destroy all weapons of mass destruction. The threat of mutually assured destruction using nuclear weapons was based on one of many off-world programs, with the goal being the complete elimination of humanity—yes, even the anti-human elites who were involved in the proliferation of those weapons as well as their use against us. We were all duped.

- **9.** Evaluate and assess all research centers and labs. If their work and purpose is beneficial to humanity, then that portion will be retained, and we will destroy or transmute all that is not beneficial. - 11. Assess and adjust training methods to improve efficiency and effectiveness.

- **13.**Prohibit harmful hazing rituals, including and not limited to rape and sodomy and any form of torture, and enforce the prohibition stringently.
- 14. Alter the promotion system to require true leadership qualities and competence, and prevent officers from adopting a cavalier attitude of entitlement to use lower ranks as servants and to take military equipment for entirely personal use.
- **15**.Require all military personnel to disavow any prior oaths and to swear oath to the men and women and communities of Canada and of the planet as a whole.
- **16.**Organize a system of local militia units, regional units, and confederate units if appropriate in order to facilitate training and economies of scale for acquisition of equipment.
- 17. Create a combined global military force with no single country having dominion or power over the other. All countries must participate and create a planetary force that defends this planet only from external or internal threatening forces, not against our own people. End all wars and settle all the issues with the ultimate goal of removing the borders, so that people and the fake created cultures are not defined by lines on a map. We will re-task or destroy all defence and surveillance-related satellites.

None of these places exist for the people's benefit. They and all assets that are connected to them will be repatriated, transmuted, or destroyed. This includes

- **22**.Employ a large team of people-based private accountants to go through all books and do a full audit, then report back to the governing bodies and the public with full transparency.
- 23. Close down or repurpose the thousands of NGO groups spawned out of the intelligence agencies, military-industrial complex, and Secret Space Program.
- 24. Slowly release information of all so-called new technology for later possible introduction to the people. This technology will be open only to entrepreneurs, not government or military contractors. Release all patents. Human ideas should be for the benefit of everyone on this planet. They are too often suppressed and find their way into the wrong hands (military, venture capitalists, etc.) for use against us and to enrich the few.
- **25**. Assemble a military task force in league with other countries and root out all drug runners, child harvesters, organ traffickers, adrenochrome facilities and traffickers, pedophile operators, and cults.
- 26. Make war an unprofitable business by imposing heavy penalties upon the military budgets for every soldier lost in the theater, every soldier maimed, and every soldier suffering mental issues due to mind control, drug issues, vaccines, biowarfare, experimentation, chemical trauma (i.e. burn pits), et al. Make the DND budget responsible for healthcare as well as battle care.
- 27.Perform a staged withdrawal of all troops in current war zones. We will also conduct a staged removal of all troops and bases from foreign soil permanently.
- 28. The branches of military can start a clean-up of the damaged areas created by troops in the people's name. The land cleanup will be done by the Army, the sea cleanup by the Navy, the air cleanup by the Air Force. The Space Command group and NASA affiliates can clean up all rogue satellites and develop ways to clean the upper atmosphere of all the space junk they have left.
- 29. As for the soldiers themselves, Veterans Affairs will be revamped with a program focused on improvement in all areas, with better efficiency as well as giving veterans freedom to choose doctors. More doctors will be hired, which will eliminate wait times and improve doctor-patient quality of interaction. Doctors will be required to provide a more holistic and naturopathic approach to treatment. Healthcare, compensation, benefits, claims, and all other programs will be reevaluated.
- **30**.Create a department within the Military for the sole purpose of soldier care, working alongside the Veterans and Health departments as equals.
- 31. Place all rogue elements into the Full Disclaimer for Full Disclosure Solution.
- **32**.Review all current military alliances with the United States and other countries to cancel or renegotiate them.

Who gains and who benefits:

In this case, everybody gains and the benefits are endless. For example, the elimination of no-bid contractors will allow for a more entrepreneurial approach, and should eliminate price gouging and cartel practices. Non-compete companies have enriched

themselves by receiving materials at 50% of cost, which the taxpayer funds, subsequently selling their war machines at great profit, none of which is returned to the people.

Eliminating all superfluous agencies will generate great savings that could be used to fix many of this country's problems. The war machine can be turned to beneficial projects like desalinization, new energy ideas, infrastructure, better housing, health and wellness, and result in less taxes, etc.

Overall quality of life will be better for everyone. People will sleep better at night knowing that our military is focused on our protection, not serving the agendas of politicians doing the bidding of foreign entities. Changing or removing technology that has been used against the people will provide beneficial results in many areas. Eliminating human trafficking, drug operations, and other nefarious activities listed above will provide a benefit for all that is self-evident. These changes will raise the frequency of the collective consciousness because people will no longer live in fear, thus increasing happiness and creativity, and improving quality of life. The above is what a real military looks like, the true purpose of which is to protect and support the people and the planet.

The Soldier Return Solution

(Written for American soldiers, but can be adapted worldwide for all military personnel)

Why this is needed:

There is a pernicious and fundamental problem in how soldiers are returned to society after duty. Many active-duty soldiers can't return home due to heavy drug and chemical use/abuse, as well as the mind-control aspect of military service, which is pervasive and goes farther than most people realize. Go-pills (methamphetamine derivatives), et al, have been a cause of many problems, not the least of which is addiction. Vaccines have been mandated continuously throughout the history of armed services and continue to cause untold damage as well. When you include illicit drugs, you can then see the problem. This is not to mention the wide-ranging psychological issues that accompany addiction and/or battlefield traumas and/or abusive hazing rituals. A common report is that the person we knew before leaving for duty is returning a much different person. The reason is in the name: They are soul-diers, not soldiers. They have died inside figuratively speaking, and in far too many cases commit suicide. This is a national and global disgrace and must be rectified quickly. We the people are tired of paying twice or more for our military programs.

- 1. Allocate 10% or more of the DND budget each year toward saving our own sons and daughters from the program called military service.
- 2. With many military bases dotted all across the country, a portion of these can easily be decommissioned and repurposed into hospital-like healing centers for returning troops. These new healing centers will aid the PTSD, maimed, MK Ultra'd, drug-addled, and poison-injected soldiers, with the goal of eventually returning them to their families whole.
- 3. These facilities will be cure centers and <u>not</u> involve drug-induced psychosis, electric shock therapy, and the current litany of unsuccessful and harmful treatments. Arrange to release the numerous known cures that have been suppressed. These will be focused on curing the soldiers long-term, based on a naturopathic and holistic approach to healing, addressing the mental, emotional, physical, and spiritual components. Hospital staff versed in all aspects of drug and chemical abuse, mind-control abuse, and PTSD recovery, to name a few, could give our returning soldiers a solid chance for recovery. This will all be done in a safe, enclosed environment until the soldiers are restored and ready to return to the public.
- 4. Returning soldiers will be treated with care and respect, and will be placed in centers as close to home as possible, with open visiting times. After all, the families will need help adjusting as well. If practical, a hotel will be built on the premises to house visitors, the costs of which will be paid out of the military budget. The more care a soldier needs, the more it will come out of the military budget to make sure these needs are taken care of.

- 5. The returning soldiers have the right to know the facts about who was really controlling the military, how patriotism and nationalism was used to entice them to join and continue service, as well to rationalize one's misdeeds while serving. Simply put, following orders is not taking personal responsibility.
- **6.** Additionally, families and communities will need training in how to reintegrate the returning troops back into the fold. Lessons from the past have been truly learned when we do not repeat those mistakes. We must implement an outreach program to assist with this.
- 7. For some, the military is their family, and one difficulty with leaving military service is losing the "family" they have bonded with. It is likely there are some veterans that have no family to go to, or have broken families and communities that cannot handle a returning veteran. Returning troops will have the opportunity to connect with a network of other veterans, which we will create. This will serve as supportive family units where they can bond and get the connections and encouragement they need while supporting one another after being reintegrated. How many vets wind up on the scrap heap because they have no family, nowhere to go, and no ongoing support after integration? We will fill that gap with the aforementioned veteran support groups.
- 8. We will include training classes on as many vocations as possible to aid the soldiers' transition back into society. Classes will be held in these centers, along with a fitness center, study material, and everything the veterans may need to get back on their feet and back home.
- 9. Careful assessment of each individual's case is required, including how they can be fully rehabilitated back into society. This will occur when the staff believes the soldier is ready and not based on a one-size-fits-all principle. Assessments for transitioning back into society will be based on their mental and physical condition, their home situation, job prospects, and funds available for living expenses, which the center can help with. Post-discharge support will be available for those who may need it.
- 10. Some will ask, how can this be implemented? Or who pays for it? It can be implemented by the people: families and communities demanding the return of their sons and daughters. Once they realize in sufficient numbers that their children are not fighting for us or the world's people, or even freedom for that matter, they will decide enough is enough, and it ends. As for paying for it, this will be accomplished using the DND budget, well over half of which currently is wasted through black budgets, backroom deals, funding lobbyists, and outright mismanagement, to name just a few examples.

Who gains and who benefits:

This will benefit the returning soldiers as well as their families. It will also benefit the public as a more well-adjusted individual will reintegrate into society.

The Bloodline Families Solution

Why this is needed:

For too long now this world has been poorly run by so called "special families," who have stifled growth, contributed heavily to wars, dictated which countries and peoples are rich and poor, thereby creating class division. These families and their monopolies in banking, minerals, food, farming, high tech, and other industries have not only stunted growth, but have caused serious damage to we the people and the planet. They are responsible for withholding patents and technologies for their own domination of industry. Their relentless pursuit of profits and wealth accumulation has caused untold damage to the environment. At no point have they considered sharing, helping the people, nor had any concern for the environment or countries.

All of these families owe the Global Trust millions of dollars, billions in some cases, and the Rothschild clan (The Crown) an even higher amount. The Global Trust, the existence of which was kept hidden, was used as a personal slush fund for these families to gorge themselves on the wealth that belongs to all of the people, and to build their own empires at our expense. The entire planet, above and below, minerals, buildings, and people—yes people—were accumulated as assets, all of which were handed over to the former Trustee. In return, the Families received pieces of paper with numbers on them (fiat currency), lots of them, and they leveraged them against the Global Trust. These pieces of paper have no intrinsic value and these Families gave away all of the real assets to the Trust. They, in essence, sold humanity out. Their wealth was built on ill-gotten gains based on favorable deals and contracts, deceiving the people and the countries.

- 1. Seguester their ill-gotten gains and disperse accordingly to the Restoration Plan.
- 2. The idea that 10 so-called bloodline or special families own 72% of American land alone is not conducive to moving forward in a sharing-based world. All of it must be repatriated back to the people. No one person, group, or country owns anything on this planet; currently it is all owned by the Global Trust. The Trustee is the guardian, not the owner of the Trust; and it can all be shared out equally to everybody.
- 3. Return all assets to the Global Trust, to be dispersed equally per the Restoration Plan initiated and approved in 2016 by a coalition wishing to re-establish justice and prosperity to the benefit of humanity and the planet. The idea that some group owns the oil, diamonds, or gold, or any other asset is the harvesting way. This failed us all, including the so-called chosen ones, special families, and certain Dragon groups. All assets on this planet belong to every individual. Companies can be compensated for mining, e.g. diamonds, but that is all. They should not own the mines, which belong to us all. Once people around the world understand this and deliver this solution, this world will become a much better place: no more wars fighting over land, countries, oil, diamonds, water, or other resources, all of which shall be shared equally.

- 4. Return all land, patents, mineral rights, and tax-haven funds back to the people.
- 5. The families like Rothschild, Rand, Rockefeller, Carnegie, Proctor, Gamble, and several others all talk humanitarianism and environmentalism, but where were their ethics and concern when their families and others looted everything with the support of the former Trustee? Task them to be involved in the planetary clean up, as it was they who caused most of the damage. The planet is messed up because of their over-harvesting in oil, fishing, tree cutting, weaponry, chemicals, war, etc. All these families have made their fortunes from raping and in part destroying the planet. They created the damage, along with the Church, banks, and royals. Repurpose all of their funds and make them take part in fixing the planet.
- 6. Request for the youth and middle-aged of these Families to engage with us, to determine how we can go forward and fix the problems together. No arrests are to be made as per our other solution of Full Disclaimer for Full Disclosure, except those involved in abusing children. Sequester their assets and leave them with a reasonable amount (\$1-5M maximum) for a more basic living style. They may say this is not enough. It is, if you cut your cloth like everyone else had to because of your greed.
- 7. Certain families can and should be removed from society altogether, given the damage they have done. Move them to a remote island near Antarctica or other suitable landmass, and let them live out their days there, but not to New Zealand as they are/were planning. They will be totally cut off from the rest of the world, with no trading, lobbying, dealing, or political interference. They are then isolated and can no longer harm society.
- 8. Place those not removed into the Full Disclaimer for Full Disclosure Solution.

Who gains:

All businesses, trading, and trade deals, with a return to what is real value, not their falsely created market values. Entrepreneurs will be free to run and operate their businesses, ideas, inventions, and plans without the overarching reach of vulture capitalists.

The Families themselves know what they have done is wrong and some want to genuinely help, particularly within the younger ranks. The fear all of the Families have is the people finding out what they have done. The fear of facing a baying public, the potential of vigilantes and other forms of abuse from a more knowledgeable public is removed by this Solution, thus they have reason to embrace rather than resist the Restoration Plan.

Environmental issues can be addressed and dealt with properly, when no longer part of some agenda. No more damaging industries that have over-drilled and abused the planet. This will then aid the restoration. Mineral sharing can be introduced to help the Restoration Plan.

Who benefits:

We the people in a myriad of ways, no longer stifled by the select few, will be free to live our lives and prosper. Society is no longer dictated to by the desire, whims, and needs of the few and can live a more harmonic and prosperous life and lifestyle. The families themselves, no longer fearing life and looking over their shoulder, and the younger elements can come and help us and repay some of their karmic debt to the people.

The Rogue Elements Solution

Why this is needed:

Crime is just about the largest issue we all face on this planet, and yet, too often the ones involved in crime are the ones that were supposed to prevent it. Sometimes this is due to coercion and blackmail at the top of each organization, and sometimes it just becomes a malignant opportunity because certain departments or groups have designated themselves to be free from oversight.

There has to be a better way of operating, where people have more opportunities to live a successful and sustainable life without having to resort to crime. Life on this planet has to return to a more fair, balanced, and lawful way. The propensity to do the most awful things on this planet in the chase for money and power has become a blight on us all. This can be addressed within each country, as to what their actual needs are to make the country viable in terms of the economic, cultural, and social needs of the people.

Crime comes in many forms other than the most obvious of drugs and prostitution. We have seen and heard of far too much of the hidden realms of crime, involving the most heinous practices ever. Examples include child sex slavery, child labour, organ harvesting, adrenochrome harvesting, and using war and disconnected migrants for many of these types of crimes. Then we have the corporate crime, the obvious being fraud on a massive scale, but the less obvious to the public is that these corporations are operating as part of an elite cartel. They are funnelling massive amounts of wealth away from the people and making everything far too expensive, beyond the reach of most people around the world. The biggest crime is that a large proportion of the world's people do not have any access to the basic necessities of life. A lack of access to water, food, sanitation, shelter, clothing, and energy in this day and age is a global disgrace to us all.

Apart from the most conspicuous crime elements, there are other categories that have committed mass crimes against the people. Recently it is Moderna, Pfizer, Johnson & Johnson, and Astra Zeneca, fronted by Dr. Fauci and Bill Gates. Other institutions that are not beneficial to we the people are the Bill & Melinda Gates Foundation, the Clinton Foundation, and the Open Society group, which is part of the George Soros enterprises. The Rothschild group and the other Families have looted wealth from the people and the Global Trust. The mass media have foisted untold lies and propaganda on the people. Walmart, Boeing, Northrup Grumman, Bechtel, Halliburton, Lockheed Martin, Raytheon, BAE, and many others gained unfair advantage by various means, including the 1976 Non-Compete Act whereby they were obtaining materials at 50% of cost. All the above also obtained multibillion-dollar deals over decades in no-bid contracts, robbing the people of their money.

It is time for the rogue elements to:

- Put an end to all military and other weapons research centers, which have done untold damage to millions of people with their human experimental trials and warfare bio-weapons.
- Put an end to the secret society groups like the Freemasons that have run not only Ottawa and the provincial capitals, but many other places as well.
- Disband all the agenda-based groups like Black Lives Matter and Antifa, whether domestic or subsidiaries of foreign equivalents.
- Cooperate to remove all gangland-based groups, most of which were created by or worked alongside the CIA and its Canadian counterpart CSIS.

Solution:

- 1. All militaries will be paid what they are owed or due, providing they all walk away from the Rothschild Clan, Dragon Groups, Secret Societies, The Black Sun, and any other groups not operating for and by the people. Their role would be to look after the people within their own country, and each country would take responsibility for its own people.
- 2. The relevant militaries and armed forces will seize the assets and operations of the above-mentioned rogue elements. This type of military operation will solve much in terms of enlistment shortages as the shortages will be eliminated by this solution. This brings an end to the coercion and blackmail of people in positions of power, which is rampant in the above organizations. The governing bodies will have more funds to spend on the people. Whole neighbourhoods and regions blighted by crime can be freed. The people will see the value of their properties rise, because with drastically reduced crime people will feel safer to live in more places. The next generation of children gains, as fewer of them will be forced towards crime, due to a safer, more inclusive, and opportunity-based environment.

Who benefits:

Every Canadian and, indeed, everyone the world over benefits as we will no longer be funding or dealing with entities that do not serve our best interests. The municipal, county, and provincial/territorial budgets will not be stretched by having to deal with

large amounts of crime within their borders. The military and its soldiers benefit, as finally they will be doing something of true value and will be working with our own people to correct the abuses, as war has no true value; in fact, all wars were started for power and monetary gain, none of which was shared with the people. All people, including security and safety people like the police, will feel safer in their jobs and homes. The people, government, provinces and counties will all have extra funds to spend on beneficial things for their communities, instead of the high cost of crime.

The Banking and Financial Systems Solution

Why this is needed:

The current pirate banking and financial models are designed to harvest our life force energy. They only work when communities are sufficiently divided and weakened in trust that people rely on the bank to provide an "artificial" form of trust — "security." Using "security," a community may still function but at a greatly reduced efficiency, and often facing consequential pain that comes with ongoing strategies to keep the community divided (vital for the banking model), including war, crime, drugs, and attacks on morality. Not once have we seen any evidence that banks are interested in the people, only in harvesting vast sums of money from them.

Capitalism is pure greed, as we have witnessed with wholesale medical fraud. The very fact that investors can hold Government to ransom is a national disgrace, and a serious dereliction of duty of the Government itself toward the people. The model and structures of this greed-based system that engage in the following practices shall not be legally, lawfully, nor morally condoned or allowed to continue to operate within the financial system.

A first step in building a new model is to remove the failed components of the old model:

- Sever connection with the Federal Reserve as it is a private bank imposing policies of fraud and theft upon the banking institutions of this country. Also remove its subsidiaries such as Citibank and Wells Fargo.
- Restore the Bank of Canada as a public institution and restore the right of Canada to mint and print its own interest-free money rather than borrow from international banking institutions that charge interest.
- Prohibit private ownership of banks and financial institutions.
- Remove the Bank of International Settlements, IMF (International Monetary Fund), World Bank, and other Central Banks as they have been a blight on Canada and the world.
- Remove marketeers, bloodline families control, shareholders, and all of the old-world failure programs from the financial system.
- Remove all trading exchanges/platforms altogether, which is another group impacting we the people with their hyperinflation.
- Remove the two-tier banking system, known as the front and back systems. The front is the public version and the back is a secret and private banking club that uses and harvests funds from the front system.
- Remove the two-tier Wall Street, Toronto Stock Exchange, and other market exchange systems also. This is another front-and-back system in which funds from the front system—the majority of global sales—are harvested by another secret and private banking club in the back system. The back system also has an algorithm advantage over the public front system, including on the floor in all stock exchanges, with a 4- to 7-second delay between the two systems. This allows the cheats in the back system to always be ahead of the game on stocks.

- Remove the Uniform Commercial Code (UCC).
- Apply a 0.1% (one-tenth of one percent) fee to every electronic money transfer and not to transfers of cash or transactions accomplished through cheques, or public money, which is defined as money minted by an authorized and trusted mint and that maintains a consistent value and cannot be debased or fractionalized, or barter transactions, to fund public welfare projects and programs.

Solution:

Nationalize Central Banks and give them to the average people to run. Call them The People's Bank (e.g. The People's Bank of Canada).

Further, create local banks, also called The People's Banks (of the community or neighbourhood), that will not be based on greed, harvesting, or fraud, and will be unable to form monopolies as their own mini-empires.

There will be no money laundering, derivatives, dodgy lending practices, mortgage scams, compound interest, etc. Signatures/ autographs and official documents of any kind may not be monetized.

Operate on simple accounting methods and eliminate complicated accounting systems that easily hide fraud and embezzlement.

Adopt a new, decentralized financial model with local, regional, country, and global currencies of agreed fixed value; with currencies, accounts, and banks, including credit unions and assurance funds, overseen in transparency by Treasury departments at various levels that are all accountable to the people; with clear procedures that enhance transparency and accountability of all within the system.

Choose to adopt the Ucadia money and financial system model, or create an alternate. Either way, a comprehensive and complete global financial system of laws, legal structures and constructs, registers and rolls, instruments of value, agreements of value, markets, accounts, credit, money, treasuries, banks, firms and goods capable of operating as a self-contained system will be needed to replace current systems.

The 14 core elements are:

- 1. Laws that consistently define the rules.
- 2. Legal structures and constructs such as rights, trusts, estates, property, and funds that establish consistent ownership, values, and administration of property.
- 3. Courts and mechanisms of enforcement that ensure the honest and impartial application of laws.
- **4.** Registers and rolls for the recording of various lawful structures and constructs of value.
- **5.** Instruments of value derived from registers and rolls, capable of being exchanged or being held as collateral and security.
- **6.** Agreements of value to signal transactions of economic value, capable of being held as collateral or security or monetized into an instrument of value.

- **7.** Fair markets for the exchange of rights, obligations, credit, goods, property, instruments, funds, and money.
- **8.** Accounts, that is, ledgers of markets and various institutions enabling recording of transactions, exchanges, and settlements.
- **9.** Credit, that is, an internal and enclosed form of money of a market, enabling exchange and the settlement of transactions.
- **10.**Money, that is, units of measure, units of account, units of redemption for value, means of exchange, and reliable stores of value.
- **11.**Treasuries as the custodians and controllers of money and the purchasers of securitized instruments and agreements, purchased by banks in the conversion of financial credit into money.
- **12.**Banks and credit unions as the providers of credit into certain financial markets and sponsors (converters) of credit into money, through the collateralization of monetizable instruments of agreement secured in the provision of credit.
- **13.**Firms, that is, trading entities within markets and the producers of goods available and capable of being sold.
- **14.**Goods (including services) manufactured by firms and sold or traded within markets.

All forms of charging compound interest, by any name, representation, or calculation, shall be considered a profane act against Divine Law and a deliberate declaration and act of perfidy, treachery, and immorality, and shall therefore be banned, forbidden, and entirely suppressed.

Who gains:

Productivity and wealth increases from the bottom up as the mechanisms of inflation and taxation, arbitrary and suppressive policies, fraud and theft, and the general uncertainty are removed and replaced by a fair system.

The true power of the people themselves is gained, working in union, freed of the bonds of banking servitude, freed to exercise their right, their duty, and their sacred honour within the true rules of law to provide new guards for their future security by building trusted communities.

Who benefits:

Individuals, families, and communities benefit from the self-determined and inspired return of investment into growth, improvement, and innovative projects that expand beyond essential needs to the spiritual goals and dreams born of higher consciousness and individual and community self-sufficiency to allow the blossoming of creativity, responsibility, and a desire to contribute and share for the benefit of all.

All are freed of the financially, environmentally, physically, and morally devastating focus on wealth at any cost characteristic of the old system that concentrated wealth and power into the hands of a very small group that have proven incapable of human qualities such as compassion, cooperation, and sharing.

The Tax Solution

Why this is needed:

The current Income Tax System is a harvesting system designed to keep the majority in or close to poverty.

Originally, most Income Tax came about to pay for the endless wars of the late 19th and early 20th centuries. Today, income taxes are collected to pay government debts accrued from pointless wars and irresponsible spending. It is a myth that income taxes pay for public services. They do not; they are a tribute to The Crown.

The banking elite bankrupted most countries by the 1930's; turned them into corporations (if they were not already designated as such); set up the Federal Reserve, the IRS and its counterparts in Canada and elsewhere, and the Bank of International Settlements; and expanded the Birth Certificate system of debt slavery. Under the Birth Certificate system, all people are born as debtors, chattel, and are used as collateral underpinning the debt bonds issued by banks to finance corporate-government spending. With compound interest, these debts can never be discharged, committing every person to a lifetime of debt servitude and taxes.

The IRS is an Admiralty institution based in Puerto Rico, collecting taxes for The Crown via the Federal Reserve. Tax agencies in most countries, including the Canada Revenue Agency, are merely debt collection agencies for The Crown. There are multiple other taxes as well as income tax, for example property tax, sales tax, goods and services tax, capital gains tax, customs and excise tax. Then there are multiple licensing fees, fines, and inflation, all of which are hidden taxes.

This system of taxation penalizes productivity. The value people produce is taxed, improvements to the land are taxed, which forces businesses to struggle, increases prices, and pushes people into poverty. This system also concentrates land ownership into fewer private hands, as people default on mortgage payments when the cost of living increases due to increased taxation and interest rates. The wealthy can then buy up land and property cheaply as ownership defaults to the banks. We have seen lots of wealth creation in the 20th to 21st centuries; however, this progress has concentrated 90% of the wealth into the hands of 1% of the population, leaving the vast majority at or near deep poverty. This level of poverty creates physical and mental health problems, drug and other addictions, crime, starvation, and untold misery. The costs to try to manage the negative outcomes of this level of poverty globally are astronomical and can no longer be sustained, leading to further breakdowns of society.

Nothing will change if we continue with the current systems of taxation.

Imagine a world where personal income is free of taxation, and any other taxes are collected and used locally rather than siphoned to foreign corporations for the benefit of self-styled elites. Revenue agencies can be run at the local community level, with a real Treasury department operated transparently for and by the people and accountable to the people.

If we implement a single flat tax, we can abolish all income tax and tax on pensions, delete licences and fees currently in existence, and eliminate most or all other taxes, ensuring no tax on necessities such as food, water, or any other products and services.

This document will introduce the land-value flat tax and address why it can solve many problems by reducing the tax burden on the people and free up resources so all can benefit equally. This will make necessities affordable and reward hard work, creativity, and innovation.

Solution:

In the 19th Century, Henry George wrote a book called *Progress and Poverty*, in which he suggests that the root cause of poverty derives from private land ownership and taxation of work and goods produced. He also shows how taxing improvements to the land, such as buildings and crops, leads to deeper debt cycles, land speculation, and the concentration of private land ownership into fewer hands.

Having defined the root causes of poverty, Henry George proposed a very simple and elegant solution:

- 1. End private ownership of land, including the ending of the concept of Crown Land. The Crown claims of title are based on fraud and theft and all such claims are void.
- 2. Lease land and right of use for a set term of 99 years, or less per individual circumstances; the land can be bequeathed to heirs and the lease terms can be renewed.
- 3. Tax the value of the land, a flat land-value tax.
- 4. Eliminate all other taxes.
- **5.** No tax for productivity, buildings, manufactured goods, or what is produced from the land.
- **6.** Manage revenues from the land tax at the local level, investing in projects and needs for local communities, with transparency and accountability.

Additional Solutions:

- 1. A healthcare wage deduction of up to 12% can enable free healthcare for all. A community assurance fund can be instituted instead, for the same purpose.
- 2. A tax up to 3% on prostitution services and on recreational drugs and alcohol can pay for the effects of these life choices on individuals and on communities. An industry assurance fund can be instituted in lieu of the tax and for the same purpose.
- 3. A sliding-scale fine up to 100% of cost of mitigation can be applied against individuals, businesses, and organizations responsible for pollution of the environment through toxic emissions; harm against peoples or regions by weapons including and not limited to nuclear, directed energy, chemical, and

- biological weapons; and or engineered harmful events including and not limited to weather and or geological cataclysms.
- 4. Punitive ill-gotten gains fine up to 100% of all financial and other assets, as well as incarceration for a specified period of time, upon conviction of crimes against children and or other Crimes Against Humanity is appropriate.

Positive Outcomes of a Land-Value Tax:

- 1. The more land individuals and organizations have, the more tax they pay. Less land, less tax.
- 2. This will end land speculation as idle land will become an expense, so individuals will be compensated for only leasing the land they can use productively.
- 3. Land values will decrease as more land becomes available, so land tax/rent will become more affordable, enabling more people to rent land or a home. Over time this could solve the homeless crisis as everyone will be able to afford a home. It will also end "market value" that drives up land prices beyond the reach of most people.
- **4.** Prices of goods and services will drop to true value and reflect the true cost. Lower prices eliminate inflation, which is a hidden tax.
- **5.** As prices drop, taxes decrease, and people will keep more of their income, meaning they can afford food, clothing, healthcare costs, and the necessities of life.
- 6. Crime will decrease over time as people are lifted out of poverty and the five basic needs are affordable. This will reduce costs to pay for crime prevention, policing, and prisons.
- 7. Health will improve, leading to lower healthcare costs, as well as reduced addiction problems as people can afford to live a more fulfilling life.
- 8. With the reduction of the above costs, more of the land-value taxes collected can be invested in community projects, infrastructure, and services.
- **9.** Work and productivity will be incentivized as people get to keep 100% of the rewards of their effort and creativity.

It will take time to implement, but this is a foundation for a system that better serves humanity.

Who gains:

All of humanity gains as wealth will be distributed more equally, and all can gain access to the five necessities of life with this new system.

Who benefits:

All humanity benefits as food, shelter, work, goods, and services become more affordable and available for all people. Crime will decrease, freeing up resources to invest in projects that will be beneficial for humanity. Health will improve, leading to less reliance on expensive pharmaceuticals and medical practices.

The Housing Solution

Imagine a world where everyone has a safe, comfortable, affordable home.

Why this is needed:

Everyone has a natural right to shelter. We also have a natural right to credit (capital), which is defined as stored or accumulated labour and represents the cooperation of all to serve the needs and desires of each. People and especially families need homes they can afford to buy, afford to maintain, and afford to repair, if needed. However, even in countries considered wealthy, there is a scandalous lack of adequate housing for much of the populace due to excessive costs of properties, mortgage interest, and rents. Further, the concept of market value skews prices by applying a false monetary evaluation based on the average price of all homes traded at market price, instead of the actual cost price of the individual home.

Solution:

- Reform the housing markets, applying actual cost price of each individual home, converting them to domain loans issued by the local bank under supervision of the local Treasury and the community as a whole.
- 2. Reduce the transactional value of a home to its replacement cost plus 10%. Lowering the price of a home eliminates the rent (premium price of land) associated with market pricing in which the new buyer pays a premium to the old owner, which represents a form of wealth transfer or speculative rent from the new to the old and which has inflationary impact.
- 3. Replace existing mortgages at remaining principal balance. The new domain loan is issued at replacement cost and at a fixed 2% simple interest rate, an interest rate that is simple interest, not compound. The interest rate is the price of capital.
- 4. The term of the domain loan can be extended to 30 years and balloon payments eliminated.
- **5.** Reduce the financial qualification requirement of buyers by lowering the price of a home to replacement cost and firming interest rate (price of capital) at the low level of 2% simple interest. This increases homeownership.
- **6.** In the event of payment-default by the loan recipient, the interest payment shall accrue to the outstanding principal.
- 7. Defaulted property taxes can be paid by the local Treasury or deferred, and added to the outstanding balance of the principal; thus, the property cannot be seized. This provides time for the loan recipient to choose between available restructuring options that may include relocation and sale of the home.
- 8. Upon sale, the remaining balance of the domain loan must be repaid from the proceeds of the sale.
- 9. Even under foreclosure, which results in a forced sale, the loan recipient retains equity rights (accumulated capital) and his/her share of the proceeds from the sale.

Who gains:

The investor of mortgage (bank or private lender) recovers the entire investment, as would happen in any refinancing. Having their capital back, they are free to deploy it in any way they choose.

Homeowners' reduction of debt service (interest and principal) frees funds for purchase of other needs and desires, including savings. Savings and principal are forms of capital created through the labour of the homeowner (wealth).

Low-income individuals and families gain the ability to become home/property owners. Since they have right of use of the home, houses can be built for the homeless, allowing the occupants to pay principal and accrue their own capital, which becomes available to them upon sale of the house, and enables them to trade up their real-estate accommodations if they so choose.

If rental property is funded by the Treasury, rents can be structured to facilitate accrual of capital by the renter who prefers not to have the complete responsibility for the care and maintenance of the housing unit. This will extend the duration of leases, which lowers the costs of re-letting.

The domain loan avoids legal costs of foreclosure and provides time for curing any default (principal or land tax payment) by the homeowner. Foreclosure becomes a last resort. The homeowner retains his/her accumulated capital (equity rights) and cannot lose everything even in the event of foreclosure. This also reduces any stress and costs associated with legal fees and court action.

Provincial, County and Local taxes broaden their tax base when homes become more affordable, because more homes will be occupied instead of sitting empty. With a broader land tax base, tax rates can be reduced, which lowers costs for all homeowners.

Increases in home value from home improvements increase the replacement cost while accruing capital for the homeowner.

Credit ratings of buyers improve because of the lower domain loan, as lower interest rate and increased savings reduces risk of default on any other loan. This reduces stress levels and enables better lifestyles for the homeowners.

As this loan system bifurcates home markets into two during transition from the current system, removal of the lower-priced sponsored housing from the more speculative housing market will increase the market values in the latter. Market value then represents the average price of the (non-sponsored) homes traded at market.

Who benefits:

Local economies improve when homeowners with reduced loan-service obligation (interest and principal), upon transferring from mortgage to domain loan, use their freed-up cash to consume other products and services from the community. This can only strengthen a local economy. A stronger local economy results in the need for more capital invested in local infrastructure and to more jobs as businesses flourish. Capital

supports jobs, jobs require capital, jobs and capital provide an upward-spiraling cycle that supports growth.

Some of this reduction in loan-service obligation can be applied to savings. Savings is liquid capital readily available to the homeowner for use at his/her discretion. In the meantime, these savings funds are held within a bank or other savings institution and can be used as capital to fund projects by others with permission of account holders. Some of this capital may be used to maintain or expand the home, improving lifestyles. Moreover, this savings can grow for retirement, to fund the homeowner's estate, to enable travel, all of which benefit the homeowner and others besides.

Because the price of the home remains permanently at replacement cost, uncertainty of home price is removed, allowing the price to float with inflation (or deflation) of home building and home improvement costs. Although it does not eliminate downward exposure to equity, it removes speculative upside in favour of building a floor under the homeowner's capital investment. From interest payments as price of capital, the Treasury or bank/credit union has funds for managing its portfolio of domain loans. Extra interest income provides the capital to expand the domain loan program, which in turn increases home ownership. The ability for homeowners to remain in their homes during a recession reduces the number of foreclosures and thus keeps home occupancy levels high, which in turn keeps the local economy supported. Widening of access to capital improves social justice because more people have their living space and are accumulating capital/wealth.

The COVID Solution

Why this is needed:

COVID fallout will be a big problem in the near future, and we are already seeing the effects of that program. If all doctors and researchers who spoke up and out against this scam are correct, then major issues will arise. Government agencies, pharmaceutical companies, CDC, WHO, Health Canada, mainstream news, and big tech corporations all conspiring together have harmed all peoples. Experimental "vaccines" and malpractice have caused deaths and illness; job losses and business closures have skyrocketed due to lock-downs, mandates, and fear. COVID is a disaster and the experimental injections are responsible for significant harm. It will also lead to massive mistrust of all departments and organizations involved in it, not least the doctors and nurses.

Solution:

- 1. Full Disclosure of the COVID scam and the experimental injections responsible for injury and death is required.
- The only lawsuits should be by people whose children have been harmed, with no excessive payouts because the children suffered due to their parents' poor decisions.
- 3. The solution for how to deal with all pharmaceutical companies is not to fine them, but to have an independent assessment done by some of the doctors who spoke out against the medical system at the beginning of this scam, plus some common sense people with some pharmaceutical background.
- 4. List all drugs and their side effects, and if any are found to have too many side effects or excessively harmful side effects, those drugs are to be automatically banned, with no appeals.
- 5. All drugs found safe or safe enough are to have a maximum profit margin of 10% across the board. This then will substantially reduce the costs to the public and will lower insurance premiums.
- **6**. All pharmaceutical company records are to be made public and identities of all shareholders are to be made public, with no exceptions.
- 7. Break up pharmaceutical companies and turn them into cooperative businesses.
- 8. All research drugs are to be assessed and must be of benefit to the people.
- **9**. All bio-warfare drugs, poisons, and harmful vaccines are to be destroyed.
- **10**.In medical companies, there are to be no CEO's, middle management, or brokers, no ownership, and only guardianship to be shared among all staff.
- **11.**Remove all members in Government who advocated or mandated COVID measures.
- 12. Review and restructure the medical boards and licensing regulations, as required.
- **13**.Remove all leading medical professionals who advocated or pushed these experimental injections.

- **14.**Dissolve the agencies and corporations purporting to be government departments altogether, and give all funds over to the Restoration Plan, which The Peoples Club (TPC) is designated for.
- 15. Remove the CEO's of all hospitals and clinics involved in the COVID fraud.
- **16**.Dissolve the Bill & Melinda Gates Foundation, and give all funds over to the Restoration Plan.
- **17**.Require all governing bodies to create a unilateral ban of all bio-warfare research, testing, and use.
- 18.The following organizations and people are to be banned for their involvement in promoting this agenda: Top brass Military; Health Canada officials and other health bureaucracies; Theresa Tam; Parliament; provincial legislatures; Governor General; Lieutenant governors of all provinces; Indian Affairs department; CEO's of all banks that confiscated funds of account holders on the basis of the Emergencies Act; Facebook/Meta, Twitter, You Tube, Google, Microsoft, and all other platforms associated with banning people who told the truth; CEO's of all hospitals, clinics, and nursing homes; all vaccine companies and producers and distributors of pharmaceuticals; news media personalities and editors of all newspapers and other news outlets including medical and science journals that promoted COVID; all school boards; CEO's of companies that created social-distancing products and sold them to business owners; and CEO's of companies that denied services or products on the basis of non-compliance with the mandates.
- **19**.Restore every person who was blocked and kept from working their jobs, and repay what they are owed from the salaries and bank accounts of all of the abovementioned perpetrators of this fraud.
- 20. Restore every business that went bankrupt due to lock-downs, which will be paid for via salaries and bank accounts of the above-mentioned perpetrators of this fraud.
- 21.Set up a disciplinary committee with medical professionals and select alternative media to investigate all research centers, and hand over all documentation pertaining to what is being done in these centers to another committee to evaluate whether this research is beneficial or not.
- **22**.Temporarily close down all medical research centers including those of the Military and Governmental and Non-Governmental Agencies.
- 23.Re-purpose several Military bases and/or concentration camps into holding centers to evaluate all the above-mentioned persons, and to assess prison time and potential for rehabilitation via teaching. Decide whether they should be used for community purposes on a low wage. This plan, with some adjustments and input from other adult-based and future-thinking people, will also remove psychopaths and greed-based people, and remove the numerous programs and agendas from being used against we the people.
- 24.All of this would be entirely paid for out of the salaries and bank accounts of the perpetrators of COVID harm and fraud, reducing those accounts down to a maximum of \$1 million.

Who gains:

Humanity and healthcare, as a whole, gain as the healthcare professions will serve the betterment of health and well-being moving forward. Those harmed by the COVID measures will be compensated. Those members of the medical professions who spoke out about the COVID fraud will retain their profession and income.

Those companies that provide effective and health-promoting remedies will continue to operate and their employees will continue to be employed. New companies can start and operate as the old medical monopoly is broken up.

Governments will cease to waste money on bio-weapons, harmful research, and medical costs associated with the COVID scam. Taxpayers will not have to pay the costs of the COVID fallout as these will be paid by the perpetrators of the fraud. The Restoration Plan will gain funds to be used to restore the health and well-being of the planet and the people.

Who benefits:

We the people that have been affected by the COVID hoax will benefit as Humanity begins a return to Sovereignty, by regaining health and regaining confidence in any future healthcare provided (see Healthcare Solution). Healthcare workers armed by full disclosure of the truth about the 'virus' and the 'vaccines,' will have better tools for helping people that were affected by disinformation and by the various mandated measures, and thus will be enabled to help people achieve the goal of self-healing. Removing nefarious influences will automatically benefit all of Humanity by shedding more light on the misinformation. All will benefit by accountability of media, governing bodies, and law enforcement, and thus trust can be restored.

The Healthcare and Health Cost Solution

Why this is needed:

The Medical / Pharmaceutical / Insurance monopoly does not serve the people. Health costs in Canada are increasing with the implementation of tiered systems and the encouragement of unnecessary and even harmful testing and treatments. This is not befitting of an advanced country, never mind a civilization. The cost of health treatment is almost as bad as the death rate of medical malpractice, which remains the third leading cause of death.

Solution:

Impose a ceiling of 10% maximum profit on any medical item, and reduce CEO salaries and perks to below \$150,000 per year. This will cut out the greedy and barbaric Insurance companies, whose costs for basic services are frankly obscene.

Require full disclosure to patients and/or caregivers advocating for incapacitated patients of the expected benefits and the actual hazards of all tests, treatments, and medicines, without deception or coercion, and require expressed consent to such tests, treatments, and/or medicines. The exception is life-saving and/or severe-pain and shock reduction treatments until the patient or an advocate for the patient can give informed consent to further treatment.

Ban all forms of malpractice insurance for medical personnel and medical facilities of every kind.

Require medical schools to teach cures rather than mere symptom suppression, and to stop the focus on pharmaceuticals and unnecessarily invasive tests and treatments. Make corporate involvement in medical texts, medical schooling, and medical practice illegal. Include the Nuremberg Code in the medical school curriculum.

Restore the Hippocratic Oath for all healthcare professionals.

Additional Solutions:

- Establish a Healthcare Assurance system, based on a 12% payroll deduction or a voluntary monthly contribution by any individual or family, that provides for medical, integrative, holistic, and alternative care. Any who choose to pay for their own healthcare can opt-out with no penalty.
- 2. Reduce the price of pharmaceutical products to manufacturing costs plus 10%. Costs of all medical consumables, facilities, and personnel to be no more than actual costs plus 10%. Wages of all corporate and administrative officers and medical professionals to be no more than \$150,000 per year.
- Establish a THI (Truth, Honor & Integrity)-led pharmaceutical assessment team to examine the efficacy of all pharmaceuticals, aimed at gradually eliminating all harmful or ineffective drugs and products.

- **4.** Create a public information campaign to reveal the real health dangers of pharmaceuticals and to introduce alternative healthcare solutions, while teaching and promoting self-care and self-healing.
- 5. Establish rehabilitation centers in all medical facilities to treat those harmed by drugs and vaccines, at the expense of the pharmaceutical companies that produced and sold the drugs.
- 6. Establish a THI (Truth, Honor & Integrity)-led medical assessment team to replace all current medical associations, (CMA, Health Canada, Big Pharma), to examine the efficacy and use of all standard medical practices used by physicians, psychiatric professionals, nurses, and all medical staff. Eliminate all harmful medical practices.
- Create a public information campaign to teach and promote self-care and healing, the use of integrated, holistic, and alternative care, while using medical care only when needed.
- **8.** Establish rehabilitation centers to treat those harmed through medical malpractice, at the expense of the physicians, hospitals, clinics, and care centers involved.
- **9.** Establish learning centers to teach holistic and integrative alternatives to medical professionals who choose to help remediate the harm they have caused and continue to practice their profession.
- **10**.Provide holistic, integrative, and alternative services alongside medical services in every medical facility.
- 11.Establish a THI (Truth, Honor & Integrity)-led assessment team to set standards of care in all care facilities for seniors, the mentally or physically disabled, convalescent care, and end-of-life care or services. The priority is to be the rights and wishes of the client, allowing for a natural, peaceful outcome when appropriate, instead of misplaced and costly life-saving measures.
- 12. Establish a THI (Truth, Honor & Integrity)-led assessment team to evaluate all advanced healing technologies that have been withheld from the general public, and schedule the release of those that are found to be beneficial to humanity.

Who gains:

All human beings will regain their health, their prosperity, and their sovereignty. All health-related systems will gain through this reform as all harms are mitigated and society and the Earth healed.

Who benefits:

Benefits will be for all Canadian people and for agents of the former system seeking redemption for the harm they have caused. The future health and posterity of all of humanity and of the Earth herself. Each solution point will curtail the actions of the "experts," as the people break their co-dependence on medical doctors and pharmaceutical drugs and products. The people benefit with a new system of sovereignty, self-reliance, self-responsibility, self-healing, caring and sharing, and universal prosperity.

The Insurance to Assurance Solution

Why this is needed:

Insurance evolved from assurance in the 17th century, where one party assured the safety of a ship or its cargo, or made good any potential loss against the ship or its cargo. Insurance falls under Admiralty Law jurisdiction as a debt security with associated penalties and obligations.

Assurance provides a surety, which is a promise, pledge, or guarantee. Surety is a solemn promise in good faith and trust. On the other hand, a security is an artificial form of trust and provides a bonding given without assurance. Thus, assurance is always superior underwriting to insurance.

People purchase insurance to protect themselves financially from future uncertainties as follows:

- Safety e.g., Life Insurance (excluding death benefits)
- Loss − e.g., Fire, Flood, Property, Auto, Health, Accident, Sickness, Death Benefits.
- Liability e.g., born from the risk of injury to third parties, covering trespass, wrongful acts, contracts, production, and events.

Like banks, insurance companies collectivize these funds and use them to pay out current claims and use the rest to invest. An insurance company has a bond with its clients, which is secured by an investment in some asset. Insurance companies also harvest our life force energy by collecting funds from less advantaged communities, investing them in wealthier localities globally, and then reaping the investment profits to create secondary markets. Insurance companies are just as involved in the monetary power accumulation as banks with their depositor demands, yet more so, because insurance companies maintain total control over payouts on contingent claims.

Solution:

- Return to assurance surety from insurance security to backstop claims. This
 requires the end of corporate ownership and the return to the principals that
 guarantee claims in the first place. The principals are members equal to the people
 themselves in assurance cooperatives.
- 2. Correct the corrupt insurance market: Stop all advertising, competition, maintenance of 40-story-building privateering empires, etc.
- Accumulate funds to be invested. The assurance cooperative will work to invest locally. The Treasury will act as reinsurer to cover any shortage in payment of excessive claims.
- 4. Cut out for-profit insurance brokers and retain local agents to assist clients. Cutting out medical insurance alone will lower the cost of healthcare due to excessive administrative costs.

- 5. Action pre-negotiated rates and premiums according to simple standards in the transition, mutualized over low, medium, and high risk rubrics within specified communities by measures such as where people agree not to live (coastlines, volcanoes, flood plains), and such as how people agree to live (eschewing pharma and engaging in other behaviours of self-mastery). There may be cases where it makes sense to devise risk classes by geographic/regional boundaries rather than by corporate enclosures (States).
- 6. In the peoples' healthcare market, use pooled funds from resources left over from premium structure to pay all support functions of the system, and offer aid and assurance to those with critical needs on a pre-negotiated, reasonable basis so families know what to expect. As people get well, the value of the pooled funds increases to serve those in more critical need.
- 7. Claimants' requests should be reasonable, not asking for inflated amounts, which will only be denied. Stop the limited economic-pie game as it only adds to uncertainty and mistrust due to competition for funds.
- 8. Implement rapid teaching and learning curricula for the body-mind-spirit, which is to find and maintain the authentic self through human feeling and expression in all aspects and protections of life, be it through denial of consent, affirmations and agreements, energetic shielding and meditation techniques, Socratic learning, creative pursuits, and internally adapting the spirit to the vitalization of the physical vessel and what lies in its field of use for the purpose at hand.

Who gains:

Lower premiums from reduced costs will increase disposable income for all and provide better lifestyles, reduced stress, and more savings. These savings can fund self-assurance and reduce the need for purchasing insurance.

Both elders and younger people will gain when all contribute to assurances underwritten to support them in their greatest time of need.

Who benefits:

Individuals, families, and communities will benefit from exercising alignment with the laws of the universe and the virtues and fortitude of right knowledge — self-control being knowledge of right choice and what must be endured and what must not be endured, and justice being right knowledge in the distribution of essential needs. Knowledge of the true order of things will instruct the people when they are bringing harm to themselves and those around them, and they will cooperate on a less material, more organic basis with the laws of intent to create a world in which all true needs are supplied ongoing. [Source: The Covenant of One Heaven, Maxims of Divine Law, Global and North American Union Charters and Canons of Fiduciary Law]

Individuals, families, and communities benefit from support in their greatest time of need. Self-supplied and monitored assurance systems encourage greater awareness of actual needs, less reliance on external systems, as well as more self-responsibility because of the limited amount of money in the assurance funds and because neighbours are monitoring the system as well.

Also, advocating for healthier lifestyles and natural life processes improves the health of communities overall, reducing costs and freeing up resources for elders in end-of-life care.

Connecting elders and younger generations in a manner that promotes recognition of mutual benefit can improve relations among generations and the community as a whole.

The Production, Income and Fair Wage Solution

Why this is needed:

What can be said about the existing corporate structures of Canada other than everything about them is wrong and failing? Corporate greed and CEO wages have created a bottomless pit of waste and excess designed to fail. The workers in large industries have been marginalized, reduced in their humanity, and robbed of their life force energy.

Greed fuels a "keeping up with the Joneses" society, with no focus on what truly creates enjoyment: connecting with ourselves and others. The few may have vast amounts of wealth, but little overall happiness, proving you cannot buy the most important things in life.

The unequal distribution of wealth creates many problems, but the core issue is what we as a society value. The time to redefine the metrics for success is now.

Imagine a world where no one is homeless, everyone is fed, clothed, and sheltered, earns a living wage, and has time to enjoy their life and family. At present, both parents typically have no choice but to work; they are neither caring for nor teaching their own children. The fact that the average Canadian has to work 5 days a week to get 2 off is obscene. It's no wonder suicide, alcoholism, and mental illnesses prevail. One of the single largest worries of Canadians is always not enough money. It's time all Canadians earn a living wage and increase their free time to enjoy life.

Indeed, the ideas behind these structures must change if we are to progress as a species. As a corporation is currently a legal person, companies use this as a way to escape liability for questionable dealings, making it far too easy for them to justify putting toxic substances in our products, whether intentionally or accidentally; creating unsafe products not thoroughly tested; using actuaries to cut corners for profits; and more.

Solution:

- 1. Abolish the corporate person with legal rights of an individual.
- 2. Make the executive board of directors of corporations fully accountable for their actions with full liability resting with them, as Trustees.
- 3. Eliminate excessive layers of management.
- **4.** Eliminate all monopolies. Mergers are to be closely scrutinized and must be of benefit to all employees and the communities they serve.
- 5. Cooperative management structure is to be implemented with equal shares of profits to all employees. Cooperatives are running quite successfully all around the world in all sectors of industry; look to these models for implementation. Management Boards are to be elected by the member-owners for a term agreed upon in the bylaws of the company.
- 6. Implement a fair wage for all, commensurate with the profitability of the business, to provide a living wage so all may prosper. Implement a 4-day work week or other altered business practice and/or calendar system that enables more time for rest

- and relaxation, gardening, family and social connections, community involvement, learning, and spiritual development.
- 7. Implement *Purpose, People and the Planet* priority before excessive profits, which means businesses are focused on the customers and communities they serve, the employee owners, as well as the health of the planet.
- 8. Encourage fiscal self-reliance for businesses and employee-owners. This will be taught to all, as profits should first be used to fuel and fund scalability, sustainability, and growth—if growth is worthwhile and not simply an old-system desire to expand for purposes of monopoly and greed. Typically, cooperatives invest in their communities, fuelling local support for community needs and startup companies.
- 9. Industry is encouraged to no longer compete, but to create standardized products or, at minimum, to share their developments with their competitors and work together to make better products for the people. Let the quality or function of the products speak for themselves and drive the sales, instead of clever marketing without intrinsic value of the products. Again, thinking must change to an "everyone gains" mindset.
- 10.All products shall reduce packaging, sell in bulk where possible, and consider environmental impact of their waste as a primary concern in creating all goods. Contaminating our environment (dumping toxic waste in rivers is one very small example) and destroying our ecosystem stops now. All the largest offenders will be accountable for cleaning this up, and a review board will be convened to address this issue.
- 11. All lobbying for use of materials or ingredients which are harmful to humans, animals, or the environment will be identified and terminated. For those that are deemed somewhat harmful or potentially harmful, the continued use must be plainly stated to consumers. Informed consent must be given by the consumer.

Who gains:

Everyone involved with these new company structures will gain. Companies will gain more prosperity in a positive energy flow by shifting focus away from profits-first to purpose and people before profits. Better quality products and a happier workforce will result. Employee-owners gain with a living wage, a share of company profits, having their voice matter in the operation of the company, and more time off for relaxation, gardening, family, and other pursuits important for personal health and fulfillment.

Who benefits:

Employee-owners benefit from higher confidence, less stress, more overall enjoyment of their job, which now has purpose, and more time to enjoy their family and community lives. Families benefit from having more connected partners, parents, and children, with more balanced lives on all levels. Communities will benefit from all of the above with happier people, which means less crime, and with more support for community or locally-owned startups. This will greatly assist in restoring our impoverished communities where industry changes have left entire towns financially devastated.

Consumers benefit from better products that are designed *for* them, not merely sold *to* them. Correcting Industry will create a more positive energy overall, which benefits the planet.

The School, Training and Apprenticeships Solution

Why this is needed:

Schooling: 0-16

Our children are the future of the human race. The current education system has become little more than an indoctrination and control system, preparing children to become useful cogs in the world of the elites. The loss of emotional intelligence, critical thinking, logic, problem solving, and creativity has damaged our children rather than prepare them to succeed in life.

For many parents, the debt-work treadmill competes for their time with their children. Parents are the best teachers. Parents need to be supported in enriching the lives of their children. Those called "teachers" have little or no actual knowledge of the subjects they are teaching, and only deliver the control system's indoctrination program by reading the script given to them.

Teachers and parents must be retrained and brought to the understanding that children must be taught spirituality, emotional intelligence, and an understanding of law, as well as true academic and life-skill subjects. The teachers and parents themselves must be taught these subjects and values in order to be the teachers that our children need. Teachers and parents must understand that they are only guardians and mentors, and that the autonomy and free will choice of each child must be honoured.

Solution:

- Provide hands-on and online resources to teach and support parents and prospective parents in nurturing and caring for their children from birth through early childhood. Guide parents in teaching their children to develop self-esteem by teaching emotional intelligence, spiritual development, basic cosmic law, and etiquette, by example.
- 2. Make affordable homeschool resources available online to parents who are able to stay home with their children.
- 3. Re-train existing teachers to nurture children's spiritual and emotional development and to respect their pupils as equals.
- 4. Give teachers and parents the knowledge that they need to teach with truth and integrity. Help teachers to become knowledgeable in the subjects that they teach and to teach those subjects that the children need to learn in order to function as useful and honourable members of humanity.
- **5.** Establish curriculum guidelines that include spirituality, emotional intelligence, law, etiquette, math, reading, grammar, history, art, science, and life skills, appropriate for all children, ages 0 through 16.

Age 0 to 5:

Establish a nurturing environment, providing all physical, mental, emotional, and spiritual needs of the developing infant and young child. Subjects of learning should include:

- 1. Physical development: reaching for and grasping objects, rolling over, sitting, crawling, walking, running, group activities, games, and age-appropriate sports, etc.
- 2. Cognitive development through self-recognition, body autonomy, and emotional intelligence.
- 3. Learning their native language and at least one additional language, including phonetic reading.
- 4. Mental stimulation through manipulating their environment, gardening, sequencing, solving puzzles, using Montessori-type materials, cooperating and interacting with others, etc.
- **5.** Spiritual self-knowledge supported and allowed to manifest in a natural way, trusting their intuition.
- **6.** Critical thinking and verbalizing learned through listening and verbalizing exercises.
- **7.** Self-expression through music, drawing, colouring, role playing, group interaction, etc.
- 8. Learning the Golden Rule of law by modelling parents and teachers.
- 9. Free play time to encourage independent thinking and problem solving.

Age 6 to 11:

Develop the mind through increasing awareness of observation abilities, discernment using brain and heart, and communication of their ideas both written and oral. Increase their awareness of their existence. Discover meaning through the semantic or symbolic significance, purpose, or values associated with a concept (mental dimension) or object (reality dimension) and the intended effect. Subjects of learning should include:

- 1. Spiritual development, meditation, expanding their understanding of the law.
- 2. Etiquette and mutual respect, caring and sharing, cooperation over competition or comparison.
- 3. True history.
- **4.** Critical (Socratic) thinking, learned by asking questions and internalizing answers through research.
- **5.** Phonetic reading and language arts, returning to trivium (grammar, logic, and rhetoric) methods.
- **6.** Mathematics, returning to the quadrivium (geometry, astronomy, arithmetic, and music) methods.
- **7.** Teaching self-expression and creativity through the arts; drama, poetry, painting, pottery, music, sewing, carving, etc.
- 8. True science (based on the cause, not the result), including earth, life, and physical sciences.

- **9**. Life skills such as gardening, grooming, basic self-care, and self-reliance (including survival skills).
- **10.**Physical Education; building strength, agility, flexibility, stamina, body/mind connection, and team building.

Age 12 to 16:

Classes need to be divided into two parts: lecture and discussion groups. Discussion groups need to be limited to six people, the size of optimal communication, with the teacher as a moderator or facilitator. This group builds a child's eloquence and persuasiveness. These group discussions must occur during school time and not after hours, which is time for family participation in the learning process.

- 1. Expand from the base created in earlier years by focusing on logic and rhetoric built from observation.
- 2. Begin in-depth study of spiritual development and the law.
- 3. Improve effective communication skills as they pertain to emotional intelligence.
- **4.** Develop their confidence in their ability to teach themselves, in making free will choices, and in understanding what it means to give or deny consent.
- **5.** Teach the principles of self-mastery and an understanding of the importance of avoiding peer pressure and the 6 hooks (alcohol, drugs, religion, money, sex, and ego) at this impressionable and vulnerable stage of their lives.
- **6.** Continue learning of language arts, math, history, science, arts, physical education, etc.
- 7. Expand basic life skills to include computer science and skills, personal finances, wood working, mechanics, metal working, crafts, homemaking skills, business creation and ethics, etc.
- 8. Begin apprenticeship programs for children who may not be academically inclined and tend to struggle academically, which can lead to a lack of self-esteem, or who lean toward practical, hands-on learning that fosters non-academic abilities. The essence of an apprenticeship program for ages 12-16, formal or informal, can cover many interests at once and involve practical hands-on learning over theory, guided by mentors who have a lifetime of experience to share.

Adult Apprenticeship Programs 17 and Up:

Trades skills and work have been denigrated as managerial and executive positions have been glorified. We must rebuild our local factories and small businesses in order to attain greater self-sufficiency on a community and personal level, and to that end we require a more competent workforce. Training and schooling must be reassessed as a whole, and their finances and sources of guidance scrutinized, especially those done by religious organizations, corporations, militaries, agencies, and politically motivated groups.

1. Ban education programs and remove teachers and administrators that cause division, promote political agendas, and disseminate false information.

- 2. Defund schools, universities, and programs that do not serve the people.
- Repurpose abandoned former educational/research facilities to serve community needs, including conversion to commercial properties and/or establishments for learning, as appropriate.
- **4.** In every school, shut down every department except for security, registration, and accounting.
- **5.** Allow for impromptu and also scheduled and private teaching sessions paid for with a donation or registration fee to fund them, until they are reassessed. Thereby classes can continue, but with a new set of principles.
- **6.** Restart the apprenticeship program by implementing tax breaks as incentives, providing free healthcare and accident insurance for apprentices/trainees and support for businesses that create their own training and apprenticeship programs.
- 7. Assess priorities for training purposes, including but not limited to critical occupations in transportation, infrastructure, construction, communications, agriculture, and food processing.
- **8.** Consider building training-focused cooperatives in areas with turn-key operations such as abandoned hotels, factories, and farms.
- 9. Encourage inter-departmental training in businesses and organizations to maximize employee flexibility as well as understanding of the operation as a whole.
- **10**.Teach the cooperative business model, which gives employees a greater stake in the profitability of the company and lowers overall costs as workers require less managerial interference and oversight.

Who gains:

Everyone gains from a teaching model that unlocks humanity's full potential and creates a lifetime-of-learning culture that eliminates illiteracy. Society gains training and learning free from corporate, agency, and military interests. Schools and training centers gain by regaining respect of students, communities, and the people as a whole.

Who benefits:

Parents, children, and humanity benefit when parents and teachers rejoice in all children's self-esteem, emotional intelligence, spirituality, understanding of law, and their ability to teach themselves throughout their lives. Communities benefit when they can produce the basics of life and thereby retain sovereignty. Families benefit when bread-winners have steady jobs or businesses, multiple skill sets (social and technical), and can take home a more positive outlook on working. Employees benefit because they have a stake in the efficiency and profitability of the company, as well as potential for higher pay and advancement and/or profits.

The Churches, Charities and Foundations Solution

All Charities should be for the people, with one aim: to empower them and free them from whatever situation they come to need help with.

Why this is needed:

Charities and Foundations have, from inception, been run mainly by bloodline and wealthy families that have served only themselves. Churches guilt their fellowships into tithing up to 10% of their gross income to the church, in which overspending and waste prevail. Across the board, corruption reigns among the largest of these organizations. The intent for many of these is money laundering, political influence, and even illegal activity, including trafficking of minors and adults alike, which ensures that nothing changes for those in need. They enjoy the tax breaks and top wages for their board members, while homelessness rises, drug addiction is out of control, and children suffer from the hand-to-mouth existence and poverty traps set up to imprison and disempower them. More money is commonly spent on advertising and fancy office buildings than actual aid. Transparency is minimal. These organizations typically use good people's guilt to ensure that those slightly more fortunate give what little they have in the name of charity and goodliness.

Charities and Foundations Solution:

- The solution is to shut down these charities and foundations, and replace them with transparently and cooperatively run community and worldwide organizations (if applicable) that will empower and provide real help, support, and aid to those in need.
- 2. Charity and foundation non-profits should pay the board less than a for-profit corporate job of equal measure of time and expertise given. This means that only people with a genuine interest in helping those in need will participate.
- 3. Full transparency of all boards, members, and monies collected and spent will be the main stipulation. Working with The Peoples Club, we can draw from our planned-out network to teach those in need how to correct their circumstances and move forward from the problems they are currently encountering.
- **4.** A holistic approach that encompasses the whole person and their issues will enable people to better themselves, with support and aids that are not monetary-based. This will encourage personal growth and self-responsibility, on an ongoing basis, until no longer required.
- **5**. A pay-it-forward approach can then encourage those that have been helped, to in turn pass this knowledge on to anyone less fortunate or in need of assistance.
- 6. With the emphasis on the perspective of the old saying, "give a person a fish and they eat for a day; teach a person to fish and they can feed themselves for life," we have then created a solid personal balance for the future for those in need.

Church Charities Solution:

1. Conduct independent audits of all existing church-run charities.

2. Outcomes:

- a) If criminal activities are proven (child abuse, trafficking, any other criminal activities), charity will be shut down, criminal charges filed, and any resources repurposed to The Peoples Club or to compensate victims.
- b) If the charity proves to be beneficial, honest, and provides needed support to the served community, endorse and support these charities.
- Implement transparent procedures to hold directors/officers/trustees of church-run charities accountable for any criminal activities and to make sure the majority of resources reach those in need.

Who gains:

The needy, the downtrodden, the impoverished, and the communities they live in will gain as resources, now spent on people rather than for profit, enhance not only the individual, but the wider community and the entire world. The drain on services that have previously been used can be funnelled back into providing teaching, training, and health programs and will create a ripple effect that will be passed down to the children and families of those that have been neglected through no fault of their own. Jobs that are more fulfilling and enriching will serve humanity in a way that builds connections on a personal and collective level. This in turn enhances the collective consciousness of the whole planet. New programs that teach skills and break addictive mindsets serve humanity and help bring an end to the costly never-ending loop-based programs.

Who benefits:

The communities that have been badly affected from drug addiction, crime, homelessness, starvation, and poverty traps will benefit. The many services that have been drained and overused, such as hospitals, addiction centers, child protective services, prisons, and outreach centers, will benefit. Ultimately, all of humanity will benefit.

The Disaster Relief Solution

Why this is needed:

Disaster Relief and Emergency Response programs have failed to organize and swiftly deliver real, tangible help to people who suffer disasters such as floods, hurricanes, earthquakes, or other natural events. Rather than helping those affected by large-scale disasters, Red Cross and other agencies collude with corporations, buying high-cost "relief items" that never get used. Those same unused relief items are then sold back cheaply to those same corporations by the agencies in a scheme of fraud and theft.

Solution:

- The criminal agencies and corporations who disguise money laundering as national aid programs must be dissolved, and replaced by recovery plans established within local communities.
- Deploy local governing bodies to repurpose central sites for disaster recovery, e.g. warehouses and strategic civil defense sites, in readiness to render care should disaster occur.
- 3. Create huge depots at strategic locations for stockpiling food, water, clothing, medical and daily-living supplies, tools, machinery, and equipment for quick access. This is to be located at least 100 kilometres from coastal areas affected by hurricanes and major storms, as well as from areas prone to flooding, landslides, avalanches, earthquakes, volcanic activity, or frequent wildfires.
- 4. Hold community meetings with peoples' groups, and include local militias and other first responders to train for scenarios and perform drills for escape plans and routes, meeting points, barricades, chokepoints, division of duties, and critical communications tools necessary on the ground to aid recovery.
- **5.** Dissolve all third-party suppliers and instead direct-source materials and distributors.
- **6.** Establish training programs for communities to learn how to rebuild and repair structures to be better than they were before, and in particular to withstand natural forces common in the area.
- **7.** Fund all Depot Centers by the surrounding communities and regions, and run them as cooperatives by the staff.

Who gains:

Taxpayers gain by no longer having funds siphoned from the public coffers to corporations and agencies. Those maintaining emergency-supply depots gain income from jobs they can be proud of. Suppliers of equipment and other necessities gain a market for their goods.

Who benefits:

By eliminating the control of the corporations in both the initiation and fake mitigation of disasters, people will be exposed only to real disasters and, if disasters occur, they will have real help when it is needed.

People will learn to future think, to get and remain prepared, and to respond calmly in the present and in the face of the unknown. The people will benefit by the flexibility to put sites and resources to many communal uses in tranquil times, including adult and childhood learning of practical applied skills such as growing, preparing, and preserving food, as well as building and trade skills. With individual communities united and trained in what needs to be done in emergency situations, first aid help across several local communities will occur when required. Of equal importance, people can learn to utilize the law of intent clearly and collectively to reverse weather manipulation before disaster can strike.

The Pedophilia Solution

Why this is needed:

We want to rebuild a society where children can thrive in a loving, caring, and safe environment. This is imperative as they hold the potential and promise of a beautiful future and will carry things forward. They must be protected from the harms of pedophilia in all forms, trafficking, and adrenochrome harvesting abuse. The damages caused by these actions to children are catastrophic on so many levels. We must move forward in the healing process that encompasses all aspects of trauma created by the acts of pedophilia: fear, abandonment and trust issues, rejection, programming, sexual traumas, mind control, alters, anger and rage, to name a few. Any shame or guilt felt by the survivor must be minimized as much as possible throughout the healing process.

Solution:

- Military tribunals are the only way forward. Many of those in the military have already seen and/or experienced similar horrors and so they are better able to cope with it. This must be transparent, with a portion of the alternative media and observers proficient in common or natural law to view the proceedings for fairness and clarity.
- 2. Give those involved a formal hearing so they may outline what they have done. There is no point in having a defence lawyer as that is beyond defensible, and no plea bargains are allowed. Broadcast all pedophiles on national TV and have them read out the full list of their crimes, with no redactions.
- 3. All those found guilty will be housed in heavily secured underground bunkers like those in which they hid away from the public to torture, sexually abuse, and kill children. This will give them time to ponder their criminality, in the very type of place many of them exerted their power over children. In addition, this puts them all miles away from the general public. No outside contact, no visitors, no perks, and no chance of parole for the evilest characters. Their only role is to correct as much of themselves as possible before their time is up here, and to work off some karma so as to not infect future timelines with their dark desires and intentions.
- 4. An opportunity may be granted to those who have been coerced and/or blackmailed into these types of heinous compromising situations. These individuals would be summoned to attend some form of a realignment camp with the possibility of being released back into society should they recover fully.
- 5. Moving forward we must create a zero-tolerance environment for this type of behaviour; the example will be set. Create a safe environment for speaking out on this. Society needs to learn to speak up and speak out to end this, as silence is complicity and consent.
- 6. The creation of The Peoples Club care facilities for survivors of such crimes will be of great importance moving forward. Those in the profession of caring for these individuals must come from a certain background or level of experience. There will be some survivors who have endured the cyclical multi-generational family traumas of pedophilia and therefore a basis of understanding is needed by

caregivers. The creation of treatment centers not connected to prisons for rehabilitation of offenders is required. It would be of great benefit to these children if past or present programmers within the bloodline families would join us in these ongoing efforts of healing the all, given their personal hands-on experience and knowledge base.

Who gains:

All children will benefit by gaining healthy boundaries. They will be able to grow up in a much safer and more stable environment and will be able to develop properly as they should. They will be able to build a strong healthy self-esteem alongside the necessary essential core values, which will help create current and future leaders of society and teach the generations to follow. The global human population's consciousness and vibrational frequency will automatically rise with this darkness being healed and lifted up.

Who benefits:

Those who have harmed others and/or children by being involved in these heinous acts will be given an opportunity to work off some of their karma. Our and future generations will benefit once this is properly addressed, is no longer tolerated, and is eliminated from human society. The hearts and souls of humanity will benefit: as above and so below, as within and so without.

The Legalizing Prostitution Solution

Why this is needed:

Funding for police, jails, court systems, and medical expenses due to this relatively benign activity that is currently considered a criminal offence is a heavy financial burden for communities and taxpayers.

Many sex workers are afraid to seek help regarding clients who are violent, for fear of being dismissed or arrested; 80% of all sex workers have been a victim of violence. Currently, violence and drugs are closely associated with street-corner prostitution. While some may choose such a profession willingly, many prostitutes have effectively been forced into prostitution because of drug addiction and/or a family history of abuse, drugs, and alcohol; others have been forced to it by poverty or by pimps.

Governments and the public ignoring the situation is part of the problem, as is the blanket denigration and condemnation of all in the sex trade. As a result, it continues in the shadows on street corners of our towns and cities, with resultant lowering of property values, and of safety not only for the prostitutes but for the public as well.

Solution:

- 1. Legalize and tax prostitution. Alternatively, the trade can fund an assurance program.
- 2. Create safe environments, proper establishments in which it can be done in house and not on the streets.
- **3**. Engage former pimps and madams to run the houses of prostitution and safeguard the prostitutes.
- **4.** This can be set up as a co-operative business amongst the workers, who may hire out a co-operative based security team.
- **5.** Ensure medical monitoring and rapid treatment of sexually transmitted diseases (STD's).
- **6.** Enact harsh penalties for those who stalk and/or assault prostitutes.
- **7.** Enact harsh penalties for forcing anyone into prostitution or the related pornography, especially children.
- 8. No databases may be collected on clients or workers, a practice that has been used for purposes of extortion, and enact harsh penalties for blackmailers.
- **9**. Offer counselling and teaching programs so that people in the sex trade have the opportunity to learn new skills toward a different profession, trade, or business.
- **10**.Place all the lead people arrested into the Full Disclaimer for Full Disclosure Solution.

Who gains:

The people pay reduced taxes for police, jails, and court systems. Sex-trade workers continue to gain revenue in what is now a legitimate job. The healthcare system can receive funds to deal with sexually transmitted diseases and other health concerns

through a tax on prostitution or through an assurance fund for that industry. The extra taxes or the assurance fund may also be put toward teaching programs made available to sex workers and to other adults.

Who benefits:

Sex workers add to their income, which gives them the opportunity for better life choices in jobs and health. They work in a cleaner and safer environment without mental and physical abuse. They can gain self-esteem and learn to make better decisions pertaining to their life and health, and can learn new skills. They can receive support to overcome any addictions. They are freed from threat of abuse, fear of incarceration, and extortion.

Police can focus on crimes involving physical harm and have time to interact more with the community in general, which improves community-police relations and enables police officers to view the public as people to protect, rather than as likely perpetrators or enemies. This, in turn, improves police officers' ability to differentiate ordinary people from criminals. Further, enhanced public respect and improved community relations will ease pressure on police officers and improve their own mental health and family relations.

Town and city dwellers benefit from cleaner and safer streets. Stalkers and violent persons can be identified and arrested, increasing public safety.

Sexually transmitted diseases are treated early and reduced overall.

Clients of sex workers are no longer under threat of extortion or incarceration.

Because prostitution is now legal and carried on in proper establishments, the seedy street-corner dealings and crime-prone districts are eliminated, which improves property values and community aesthetics.

By bringing prostitution into the light, communities can work together on solutions for mental-health, drug, and alcohol issues that cause suffering not only to individuals but to society as a whole. When members of the sex trade can learn the skills to be better, more productive people, the quality of society improves.

The Gangs and Drugs Solutions

Why this is needed:

When it comes to alcohol, tobacco, and drugs there is no regulation of pesticides, synthetics, and additives used for the processing of the finished product. It is a freelance industry with an almost unlimited open door to poison people's minds, bodies, and spirits. Ultimately funding the downward spiral of those who ingest these products, the profits go back into the pockets of oligarchs and criminals who have no regard for organic life in general and humanity in particular.

People do not know what they are taking into their bodies, because the ingredients are not listed to provide a free-will informed choice.

Too much time is taken from the police on subduing violence and theft created by a system that is put into place by their controllers, and people's tax money pays into that same feudal system. It interferes with the enforcement of valid law by men and women that want to make positive changes in the community that they live in and with.

Solution:

- Submit and/or test by approved laboratories all tobacco, alcohol, and drugs/controlled substances for synthetics, poisons, pesticides, and additives of all kinds.
- Regulate manufacturers of alcohol, tobacco, and drugs/controlled substances and require that their products be labelled with a list of all ingredients and contaminants.
- 3. Legalize drug, tobacco, and alcohol sales and consumption with no rules, no regulations, and no incarcerations unless users commit crimes such as robbery, vandalism, or violence. The legalization of drugs has been proven in Holland, Portugal, Germany, and Venezuela to drastically reduce crime, deaths, and drug abuse.
- **4.** Create a drug division within social services programs, hospitals, and dispensaries whereby the drugs can only be sold there or in the pot distribution centers, which takes it off the streets and out of gangland control.
- **5**. The current pot and alcohol shops are to be given the resources to expand the shops to include a support structure for the users.
- **6.** All centers have staff made up of people who have sold and/or taken drugs and wish to give back to society.
- 7. In these centers, only four questions are required. 1: Name? 2: Address and contact information? 3: Do you want help with your addiction, yes or no? 4: If answer is no, what item and how much do you require? That's it, no lectures or finger pointing, just a straight and easy transaction. This now places the responsibility onto the people who choose to purchase these substances. They are responsible for their own actions. They exercise their free-will choice and no one is responsible but them for the consequences.
- 8. Place all gang leaders arrested into the Full Disclaimer for Full Disclosure Solution.

9. Add a tax up to a maximum of 3% on sales of drugs. Alternatively, a dedicated assurance fund can help to mitigate problems associated with addictions.

Who gains:

More jobs are created, such as technicians for labs and testing facilities, as well as coaches to teach on various levels. People who do have addictions will have resources available to them that they can relate with to get clean. Police can spend more time with real problems in the community. Former members of gangs and former addicts can be employed in the legalized system and help others in the process.

Who benefits:

Extra taxes help local and regional budgets. If the alternative of an assurance fund is chosen, some of the funds generated would go into teaching programs, which creates more jobs to really teach the public not only of the external dangers, but the far more damaging internal dangers these drugs produce. Too few people are aware of the influence of dark spirits and possession of the vessel/body enabled and initiated by using these drugs.

The Science and Technology Solution

Why this is needed:

Humans are tripartite: of body, mind, and spirit. We live to advance our spirits by growing our minds and hearts. Everyone is different and achieves this objective using their own unique paths; our decisions are ours. Free will and choice is the greatest of all possible forces within the universe. The very existence of existence itself depends upon free will and choices made with our rational minds and depth of feeling. Free will depends on the information available, free of coercion. However, most people abdicate their free will by following recommendations by authorities, or "experts" in their field. Currently, science and technology are part of the control system rather than information providers sourced independently to assist us in making our choices.

Etymologically, science means knowledge acquired by study, and assurance of knowledge and certainty, whilst technology means a system or method of making or doing. Both are a convenience made readily available to make our choices easy.

Science is presumably about finding the truth; however, it is biased by the observer's prejudices and beliefs, the egos of experts, and selective assignments of institutional grants to limit discovery and knowledge expansion, which in turn limits understanding of truth. Scientists seek approval and decry dissent of their peers; thus, theories—which are at best partial truths and at worst putative opinions—persist longer than necessary because of inherent biases in the scientific community.

Major leaps in knowledge can occur when an individual discovers a new approach toward things unseen and the community organically accepts it. This is rare because experts promote themselves as having complete knowledge of a topic with specific results, and are never subjected to full discovery or exposure. Technology is good when it is beneficial to humanity, as then it can increase productivity, efficiency, and effectiveness; however, information technology can also be used to data-mine and spy on the population, which is then monetized by marketing organizations and the control system. Marketing is an economic form of electric induction, keeping buying habits (a form of energy harvesting) on a particular path. The control system can use this information to coerce and regulate mass compliance.

Solution:

- Demand access through technology to additional information that we can use to improve our choices. Individuals must use their free will only with informed consent to make their choices. No external authority is the decision-maker amongst a populace of sovereign individuals who have the research and facts.
- 2. Make information sources public utilities because they are open gathering places just like parks, which are known as the public commons. These technologies provide a non-discriminatory service to access all available information without censorship. Allow individuals to choose the efficacy of all information, not the controlled public utility.

- **3.** Create individual subscription services, grants, contributions, or some form of collective funding to provide cash inflow for information technologies, thus removing advertising revenues and funds from the control system.
- 4. Remove data mining at targeting functions to create time savings in coding development and maintenance, which will protect user privacy.
- 5. Remove "national security" labelling to make new discoveries or patents available to the entire world and close the patent office altogether. This will increase awareness of what is possible, limit potential for monopoly that attends patent restrictions, and inspire others to continue developing new technologies that improve productivity, efficiency, and effectiveness.
- **6.** Address funding sources, particularly for academic science, through grants. Academic scientists are exposed to conflicts of interest compounded by their egos, and must be paid by their institutions or create their own consultancy.
- **7.** Broaden peer review to dissenters in order to distribute alternative opinions and observations, which enriches the information available to all.

Who gains:

The true power of the people—to make their choices based on access to a wider range of information. This will free them from the bonds of the technology companies and the scientific community who, by default, coerce many into decisions pre-prepared for them by the control system.

The scientific community improves as other opinions are fairly reviewed and disseminated, even if not published in journals. The expression of someone's opinion is another's observation, which leads to a better understanding of the issue or topic confronting researchers.

Technology business improves as it meets the productivity, efficiency, and effectiveness needs of its customers.

Who benefits:

Individuals, families, and communities benefit from self-determined and inspired access to information and thus to improvement in their ability to make choices. This allows them to take responsibility for their lives within the collective and reach their spiritual goals and higher consciousness.

The Essential Services Solutions

1. Cooperative Utilities

Why this is needed:

Making excessive profit on the basic needs in life must end if we are to progress as a species. The business model for the essentials in life should not be a profit-making enterprise. Everyone on the planet should be cared for and considered, with access to the basic essential resources for living.

Solution:

- 1. All current investor-owned, CEO- or government-led water, utility, mining, and refining companies, including the infrastructure of such, are to be seized and transitioned into private self-managed cooperatives with an elected board to run them. This includes water, electricity, solar, wind, hydropower, nuclear power, and all in-ground resources such as oil, natural gas, and minerals, as well as communications (phone and internet) services, which can be cooperatively owned by the people.
- 2. Grant money from the budgets of governing bodies is to be allocated to establish these initiatives. Existing utility co-ops can assist in this transition greatly.
- 3. All profits are to be set at a maximum of 5% to 15%. The surplus goes to the co-op member/owners, local co-op initiatives, or the Federation of Global Cooperatives (TPC) for future sustainable initiatives for and by the people.
- **4.** Existing co-op utilities will be examined and assessed for viability, as several of them are run by third-party management corporations.

What is a cooperative?

There is a long and rich history of cooperatively led utilities (and many other businesses) which are still successfully operating to this day. Each cooperative is a private, nonprofit business owned and governed by the consumers that it serves. A utilities co-op is managed for and by the community it serves, giving each customer the opportunity to participate in the governance of the co-op. Being inherently tied to the local area, co-ops are often involved in community development projects, support of local businesses, and job creation. A cooperative is a values-based business, owned by and operated for the benefit of the people as the heart of the organization, not for outside investors. Each cooperative's membership will elect its board for a specified term such as 4 years.

Who gains:

The country's governing bodies through having less to regulate and manage, the country through creating and controlling the infrastructure in our own country, the local economy and the communities each cooperative serves.

Who benefits:

Consumer member-owners, and the employees through job creation in a sustainable business.

2. Food security for our future, a self-reliance strategy

Why this is needed:

It might be argued that the ability to control the production, distribution, and quality of foods is now one of the most important freedoms a nation has. With the power of food production in the hands of the people, corporations and market institutions are prevented from dominating the global food system and, through such domination, controlling governments and populations.

Currently, 51% of Russia's food is grown either by dacha communities (40%) or by peasant farmers (11%). The remaining 49% of production was left to large agricultural enterprises.

Russia is not the only nation to produce such a large amount of its own food: Havana, Cuba reported producing 90% of the city's produce from local urban farms and gardens.

When one digs deeper into the numbers reported by the Russian Statistics Service, however, some very impressive details are discovered. During the communist period, 90% of the nation's food came directly from dacha gardens. In 2011, dacha gardens produced over 80% of the country's fruit and berries, over 66% of the vegetables consumed, almost 80% of the potatoes consumed and nearly 50% of the nation's milk supply, much of it consumed raw. This is likely because in 2003 the Russian government signed the Private Garden Plot Act into law, which entitled citizens to private plots of land for free. These plots range from 0.89 hectares to 2.75 hectares, and allow the people to contribute to their own food sovereignty.

A similar homestead model that has been proposed, in which the free land may be bequeathed but not sold, would allow an individual, couple, or family not only to live self-sufficiently but to sell excess produce, hand-made craft items, or skills and talents, all of which would be tax-free.

Solution:

1. Adopt the Russian dacha and homestead models and give everyone the opportunity to own a plot of land as their home or near their home as a weekend retreat as we move to a 4-day work week or other calendar alteration and business practice that facilitates gardening, reconnection with family and friends, and connection with the natural world. The land is to be redistributed from Crown lands, those currently owned by the elite bloodlines, and those seized as ill-gotten gains from other individuals or groups. Create assessment teams to evaluate the soil conditions in each region for this purpose. Existing farms will be changed to regenerative biodynamic and permaculture farms without the use of toxic chemicals.

- **2.** Farms are encouraged to form farming co-ops that engage local people as labour when needed.
- **3.** All farms will work together instead of competing with one another, ensuring all farmers have access to resources, grain, etc. "When one thrives, we all thrive" is the mentality going forward.

Who gains:

The governing bodies, which will have less land to manage and oversee. The country, through becoming sustainable in its food production, with better quality food and without destruction of the environment and the soil. The planet, which is being destroyed very quickly by current agribusiness practices.

Who benefits:

The benefits of the dacha and homestead model include self-sustaining individuals and families; increases in food production and quality as homesteaders share their excess with neighbours and nearby communities; environmental improvement as orchards and native trees planted by homesteaders balance precipitation patterns, and as people feeding themselves from their own gardens and husbandry will avoid using harmful chemicals and mutant seeds in the production of that food; and increased birth rates can be expected when couples know they can provide a bright and healthy future for their posterity.

On a wider scale, such a program would force employers to increase wages of employees who now have the opportunity to operate a micro-farm homestead instead of work for hire. Better wages improves local economies as workers can now afford to buy more than mere subsistence items. Further, a homestead could be offered to military and law enforcement protectors to give them the incentive of a piece of the land and community they protect.

This caring and sharing model benefits the entire population, local communities, families, and individuals through restoring connections with our food, putting care into our food production, and connecting with each other, ourselves, and the planet.

The Food and Soil Sustainability Solution

Imagine always having access to plenty of safe, healthful food.

Why this is needed:

Soil conditions have been degraded all over the Earth by overuse of chemical fertilizers and herbicides. Farm practices in growing vegetables and raising animals for food have become factory-based. The use of drugs, chemicals, and genetic modification to maximize production and profits shows little concern for the welfare of animals, destroys both the farm and surrounding environment, and causes harm to the people who eat the food. Greed-based food production and price manipulation through destruction of inventory has increased the price people pay for food. The overpriced food is left to rot on store shelves and is thrown away while people starve. Government policy particularly around food is being controlled by unethical corporations that have conflicts of interest and/or have been infiltrated by those with anti-human agendas.

Solution:

- 1. Encourage farmers to grow again.
- 2. Dissolve Agriculture Canada and similar agencies in this country and in countries we import from in order to end the government interference in agriculture.
- 3. Repeal all laws banning the production of our own food.
- **4.** Sequester land owned by wealthy elites, corporations, and other organizations, most of which was obtained by illicit means, and give portions of it over to communal gardens and dacha or homestead plots to grow our own food.
- 5. Given that Russia receives 60%+ of its produce from people growing food in their own yards or gardens, Canada can also become food self-sufficient by similarly encouraging individuals and families to grow food instead of lawns, and to husband a few domestic food animals such as chickens on their properties. Even balconies can provide spaces for food production.
- **6.** Ban genetically modified organisms (GMO's) invented by companies like Monsanto, Bayer, and Syngenta.
- **7.** Return to a healthy food production system based on organic and permaculture farming methods.
- 8. Expand genetic diversity by encouraging all food producers at every level to use open-pollinated and heritage varieties of cultivars and breeds of domestic animals, as well as encouraging the cultivation of edible species that are not currently grown for food.
- 9. Do away with plastic packaging, over-processing, added chemicals, dangerous pesticides and herbicides delivered by companies like Monsanto and encouraged by Agriculture Canada.
- **10.**A cease and desist of deliberate spoiling, ruining, flooding or dumping of toxic waste onto food production areas, or destroying inventories of sound foodstuffs.

Additional Solutions:

- 1. Recognize food security as an essential human right.
- 2. Make food affordable and available to all people.
- **3.** Encourage local resource networking, sharing and caring, plant exchanges, and farmer's markets.
- 4. Repeal existing non-compete legislation and ban future creation of any form of Non-Compete Act.
- **5**. Make farming, food processing, and food sales essential services.
- **6.** Create legislation that ensures that people can donate food without fear of litigation.
- **7.** Create a public information campaign to raise awareness regarding food conservation.
- 8. Encourage the formation of food distribution routes to reduce food wastage from grocery stores and restaurants, by gathering un-sold foods and delivering them to soup kitchens and pick-up spots for homeless people and low-income families.
- **9.** Create advertising sites to direct people to farms and gardens that have excess produce that needs to be gleaned or gathered, with that produce or a portion of it to be given in trade for the labour provided.
- **10**.Teach adults and children to recognize spoiled foods. Arrange for food waste that is not fit for human consumption to be gathered and delivered to farming areas to be used as animal feed, or delivered to community composting sites.
- **11.**Create a public information campaign to adjust peoples' expectations of perfect-looking generic produce.
- **12.**Review expiry dates on food in stores and eliminate where appropriate.
- 13. Share knowledge to bust the myth that it is impossible to produce enough food without using modern farming practices such as tillage, mono-cropping, and the use of chemical fertilizers, pesticides, and herbicides.
- 14. Establish The Peoples Club/TPC-led assessment teams to:
 - a) Evaluate the contamination of the food supply through the practice of producing animal foods that contain animal remains (such as cow remains being fed to cows), and prohibit this practice.
 - b) Evaluate the contamination of food containing human remains and prohibit this practice.
 - c) Evaluate other food contaminants such as animal feces, insect parts, and environmental toxins (drugs, petroleum products, chemtrail residue, plastic, chemical and mineral residue, etc.). Require that these contaminants be eliminated when possible, and that all ingredients, contaminants, chemical residues, and metals be listed on packaging labels with their percentage rates.
- **15.**Create a uniform plan for soil recovery.
 - a) Incorporate this soil recovery plan into the children's school curriculum and make it available to adults through seminars, videos, and intern programs.
 - b) Include subjects such as composting, no-till methods, vermiculture, soil biomes, permaculture, plant diversity, etc. in the curriculum.
- **16**.Evaluate all chemical fertilizers and ban those that are harmful to human, animal, or plant life.
- **17.**Provide economic incentives to farmers who convert to use of approved and/or natural fertilizers and methods.

- a) Assist farmers with travel costs and tuition costs associated with learning to use original farming practices.
- **18.**Identify and destroy all GMO crops and seeds worldwide, at the expense of the companies that created and distributed them. Dismantle the companies that created them.
- 19. Eliminate government or corporate laws or control systems (such as taxes, licensing, and registrations) that restrict or prohibit any reasonable use of farm or urban land for private or public food production and use of edible plants and/or animals and animal products.
 - a) This must include the right to harvest and process edible plants, animals, and animal products for private or public use, or for trading or selling to others for their use.
 - b) Establish fair land-use guidelines that will allow any person or persons to have free, dedicated access to a portion of viable land to produce food sufficient for their needs.
- 20.Address the problem of environmental contamination due to plastics by providing incentives to produce alternatives to plastic, such as natural-cloth bags or such as harmlessly degradable bio-plastic created from sustainable organic non-toxic sources.
 - a) Encourage the production of alternative packaging that is non-toxic and is biodegradable or otherwise degrades in a manner harmless to the environment.
- **21.**Engage agricultural associations worldwide, with purposes that are compatible with TPC values. Give them the opportunity to contribute to the solutions for humanity, give feedback, and share their knowledge.

Who gains:

All humanity gains as food security becomes a human right, with food being accessible to all people worldwide. People, including the children, will gain a wealth of knowledge about sustainable farming and self-reliance.

Individuals and families that grow some of their own food will spend less money on groceries, which means they will require less labour effort to earn income, will have more money for other needs, and more control of their life on many levels.

Farmers will save money and no longer be dependent on the corporate production of chemical products.

There will be an abundance of work for everyone. Discoveries of plastics alternatives will create new industries and hence new jobs.

Who benefits:

Humanity benefits through healthier living. The environment benefits from regeneration of the soil and detoxification. The earth benefits from the rise in the vibrational frequency of all that dwell on her.

The Mass Media Solution

Why this is needed:

Mass media has been monopolized with only six organizations controlling all the world's media outlets — television, print, radio, and internet. This monopoly has had a devastating effect on all peoples and countries. It has created enormous stress on many peoples, and lowered intelligence levels of the public that is induced to believe in blatantly false stories, specious interpretations, and distortions of the truth. We must address and eliminate the one-story-only policy that is exhibited on all channels and all media outlets of the elite-controlled monopoly which deliberately confuses and misinforms. The mass media commits treason on a daily basis against the global population with propaganda, agendas, and divide-and-conquer scripts that are mostly lies. The "nothing changes for the better" scripting is weaponizing news against we the people with 24/7 predictions of doom and gloom, facilitating a lowering of the global collective frequency.

Solution:

- Create new entrepreneurial companies out of the alt media, to start presenting truth and interesting topics that teach people, all to be funded out of the assets of the mass media companies themselves.
- 2. Employ the mass media personnel in the Disclaimer program to be explained later, and in community service.
- 3. Remove all the intelligence agencies and military involvement in the news.
- 4. Report positive-based news of how life is improving around the world.
- **5.** Encourage people to come and work together, to heal the division created by the news media cartel.
- **6.** Eliminate all legislation that promotes government control of media including CBC (Canadian Broadcasting Corporation) and Radio Canada, media monopoly, false news and history, division programs, censorship, racism and other anti-human agendas, and create a transparent Act that benefits all of the people.

Who benefits:

The people, who will no longer be harvested by the corrupt media monopoly, and communities' true needs will be met with truth, honour, and integrity.

The Water Solution

Imagine a world where everyone has enough clean, safe water.

Why this is needed:

Our most precious resource is the subject of scarcity programs too numerous to list, and is provided to the people as dormant bulk water that is denatured, stagnant, and electromagnetically incoherent. It is also provided at hugely inflated prices when humanity deserves to enjoy complete and affordable public access to clean, plentiful supplies of water for all activities of daily living, both indoors and out. If we want to live fully, it is long past time to end all water restrictions and ban weather weapons and other perverse methods of engineering water shortages, droughts, floods, and poisonings.

Solution:

- 1. Repeal all legislation that makes water a commodity and denies the right of the people to water.
- 2. Remove or regulate companies that siphon water to sell as a product or that otherwise overuse water supplies.
- Stop and ban the pumping of untreated effluent into our seas and other waters as this practice damages our beaches and sea life, which in turn contaminates our food supply.
- **4.** Fine any company that dumps illegal chemicals or damaging substances into our water systems, including rivers, canals, lakes, aquifers, and oceans.
- **5**. Ban use of chemicals in farming and other industries that ultimately contaminate our water.
- **6**. Ban the practice of adding poisons including fluoride to the public water supply.
- 7. Clean up lakes, canals, rivers, and oceans so a proper ecosystem can emerge.
- 8. Sequester to the people the water companies and make their profit margin minimal (10%).
- **9**. Cease and desist the siphoning of water from Canadian waterways to be diverted to or otherwise sold to other countries.
- **10**.Bottled water will be sold with proper (high) pH, in toxin-free bottles.
- 11. Make water testing transparent and make results public to everyone.
- **12.**Local councils and authorities are to be held responsible for old and damaged pipes that leak and drain our reservoirs.
- 13.In flood zones, form and maintain fleets of trucks with pumps to drain floodwaters and move the water to where it is needed, such as drought-depleted river systems that feed large areas. This helps hydro-power systems as well as drought-stressed areas. Pipelines could be manufactured and laid down for a similar purpose. Floodwaters would have to be completely decontaminated, purified and revitalized either before, during, or after their transportation and redistribution.
- **14.**Construct desalination plants along all coasts as backup for water supplies; this will lower oceans slightly, prevent more coastal erosion, and provide sea salt.
- 15. Make piped water available in all homes.

- **16.**Abolish all laws that ban harvesting of precipitation (rainwater and snowmelt collection) and other sustainable water sources by the people, as well as laws that ban building and use of greywater and blackwater systems of purification.
- **17**.Encourage and enable small-scale water harvesting and purification by homeowners and businesses.
- **18.**Redesign urban environments and building practices to improve hydrology and natural precipitation patterns, as well as to minimize flood potential and flood damage.
- **19**.Begin to deconstruct dams on a case-by-case basis based on the availability of new technology; this will allow for and teach that water's essence is to flow freely.
- **20.**Encourage schools to make use of rainwater harvesting by involving the children in projects that can also be used in homes. Encourage companies to practise rainwater harvesting.

Who gains:

Everyone whose body cries out for water and whose deep dehydration has led to negative health outcomes including infertility, aging, and death.

Communities that have been paying inflated prices for water supplies and/or for poisonous additives for water supplies gain cheaper, cleaner water. Communities and regions that have had their water supplies depleted by companies that siphon the water for their own profit gain stable water supplies. Communities and regions whose water supplies have long been poisoned by industry or by agricultural runoff gain cleaner water. Communities that wish to nourish their members with beautiful fountains, parks, well-irrigated gardens, food forests, rain forests, and abundant marine and freshwater aquatic ecosystems gain the ability to do so.

Coastal communities that build desalination plants increase local employment and gain by marketing clean sea salt.

Who benefits:

It will help the environment and all species of the planet that rely on water for their very life

Communities subject to drought and communities subject to flooding benefit.

Householders and small businesses become more self-sufficient by harvesting precipitation and/or by purifying their own wastewater.

Children gain an appreciation for natural hydrological cycles and an understanding of how to live self-sufficiently.

The Full Disclaimer for Full Disclosure Solution

[originally written for the U.S. but applicable to all countries]

Why this is needed:

This world is a disgrace and an embarrassment, riddled with the most evil of crimes against humanity, and yet no one has come up with a solution to correct these ills. Much of the world's crime is driven by engineered scarcity, whereby many people have no option but to get involved in crime.

We have presented a range of solutions to fix this world and operate in a more fair and transparent way—solutions where everybody gains, the poverty class is raised up, the lower class is raised up, the middle class is more balanced, and the richer class who fear a baying public will be offered safety and security in return for helping us restore this planet.

We have one problem left to deal with which pervades society in all positions of power, that destroys the ability to make common-sense decisions, that does not allow for those in such positions to help or aid the public in any way, a problem steeped in agendas formulated by lobbyists and think tanks that are the bane of our western society. Here is our solution to that problem.

The background:

All positions of power and the people in them, be they government, intelligence agencies, or military, are operating under a strict code of coercion and blackmail. Vast databases hold information on every person including what crimes they have committed (coerced or not) and their sexual preferences. Further, outright schemes have been devised to lure and entrap them into doing something wrong, to then leverage them into doing the bidding and the work for the hidden elements of society who do actually run the governments.

Politicians and others are terrified to make their own decisions based on some misdemeanour of the past. Formerly, homosexuality was a common hook. Nowadays it can be drugs, prostitutes, or the worst variety of underage sex with minors, again whether coerced or not. I say "whether coerced," as there have been several instances whereby officials were set up by rogue intelligence agency players to trap them into doing something wrong, to then be forced to do their bidding. This is a largely hidden game, operated under a cloak-and-dagger tactic, far away from the public eyes, and is a disgraceful way to operate.

Are our so-called agencies and military in some cases operating against the people? It leaves many questions but delivers few answers that make sense, leading to lots of speculations like: Are these our people at all? Why would so many operate in a manner not beneficial to humanity?

The problem, as we see it, cannot be fixed or remedied, and like our other solutions requires a radical overhaul, which only a blank slate or tabula rasa can bring. The

following is a new common-sense solution for the governments and all other leading officials, that ends the blackmail issues, ends the retribution cycle and, if developed and administered correctly, can send us toward a more adult way of thinking and positive path.

Anna Von Reitz mentioned recently about the treasonous acts by several leading officials, several of whom will potentially be hanged; if true what happens next? The masses will demand blood and/or incarceration, which is understandable with the people's current mindset. But what happens if officials are arrested? What next? Ridiculous lawyer fees? Endless debates? Hate and anger groups or vigilantes? Plus, it will cost an estimated \$90,000 a year per person to house them in prisons, wasting more taxpayers' money.

What if there was an alternative? A move away from the mass finger pointing and blame game? A move away from endless hours of sanctimonious drivel spat out by the mainstream media on these topics, while hiding their own role in the cover-ups. A move away from the unlawful BAR-system based lawyers, who would all rub their hands in glee and collect vast quantities of funds on the cases, which the public has to pay for.

One of the major obstacles to correcting these issues is people being frightened to speak up and out. We can continue with the lies and cover-ups, which eventually make their way to the fore anyway, or make a radical adult-based decision. Everyone has done wrong things, and everyone has been lied to, fooled, duped, threatened, tortured, and mind-controlled. What is left is a broken planet with broken systems and nothing works as it is stated to do. We can carry on with the child-level antics of blaming everyone else, or come together and formulate a real plan for the greater good of all.

My plan is for a platform to be created for full disclosure of all crimes in return for a full disclaimer (amnesty) unless those crimes involve harming children. It is a planetary-wide blank slate and a real reset—in our image, not the dark forces' image.

The background to this is several pronged:

- 1. Our government is over-bloated and it is too expensive; \$14.5B+ a day [for the US alone] is a scandalous waste.
- 2. Many jobs need to go, and many in high level government positions have committed criminal acts.
- 3. All are blackmailing each other to keep their criminal acts under wraps.
- **4.** Prison populations are overcrowded. Adding many more to prisons creates more costs for the taxpayers.
- **5.** Drastically reducing government jobs in one go will in part crash the economy. This can instead be done in a phased in and phased out operation.
- **6.** Things need to be addressed in a better way for karma reduction, and as a remedy to society for officials' failure of duty.

If many of the officials are guilty, then what are the solutions? Should they go to jail? But part 4 above states that is not cost effective, and where to put them is another issue. So how can this all be achieved with one solution?

Solution:

- Create and sign an executive order [a statute or law in Canada and or in the provinces and territories] allowing for all government, military, agencies, and subsidiary groups connected to these a full disclaimer for full disclosure, unless involved with crimes or abuses to children.
- 2. Call it the Truth, Honour and Integrity Act, because those three traits are what will be required to move forward. This will allow many to come forward and speak up, and will end the blackmailing culture and fear that pervades the corridors of power. Many want to speak up, but live in fear of being potentially exposed for their own misdemeanours or roles in those of others. Many of these people did not start out as the bad guys, but the whole culture and setup of this group is designed to trap all who participate in it, in any way possible. Their purpose is to gain leverage over you so you then have to do their bidding and dirty work, or face being exposed, or in some cases murdered along with your family. The Kennedy family is a prime example of this, although none of them are or were clean either; in fact, the whole family are Black Sun members.

So how do we fix it?

- Create committees based on the criminal acts undertaken and place those corrupt officials who come forward on the relevant committee. What is the purpose of the committee? The corrupt officials will have a safe environment to reveal all the others who were involved in the criminal act(s).
- 2. Disclosure: Who gave them the orders? Who did they work with? Who was involved on a wider scale? Which countries and/or governments were involved? What contracts were made or signed? Who did the deals and who gained the most? What banks were involved if money was part of it? Reveal all the bank accounts, confiscate them all, and close down those accounts.
- **3.** Sequestered funds are to be returned to the country or countries they came from, including assets stolen.
- 4. Establish an espionage committee, government contracts committee, foreign contracts committee, and the list goes on. Each participant in this program would join the relevant committee and reveal all the crimes they were involved in and who with.
- 5. Create a database to house all disclosed information, to eventually be made available to the public with the crimes redacted. The name-revealing will not matter, as people will see their public officials are no longer in their previous position.

Who will administer it?

 The database will create jobs for those being moved out of their former positions who haven't been involved in criminality or who haven't come forward as an accomplice.

- 2. There will be jobs for analysts, researchers, investigators, and general office positions. This will then provide detailed analysis for analysts and researchers to pore over and can be used to bring in other people over time.
- 3. The lower-ranked military, state guards [in America], or militia can do the removals, with the full backing of the law and with support to do so.
- 4. Use designated buildings, preferably some that are up for sale or in need of repair in a downtown area, which when refurbished can be used for a better purpose when this task is completed.
- **5**. Each state [province and territory] is to have one building with enforcement at each building, preferably lower military or National Guard [Canadian militia] members on an assignment basis.
- **6.** Employ members from our Truth, Honor & Integrity group, as many of them have the knowledge of various criminal acts and will understand the logistics. Use other alternative media show hosts or listeners to oversee transparency and fairness. These will be temporary jobs until the task is completed.
- 7. Those in temporary jobs can potentially be employed elsewhere in government positions to prevent these crimes from ever occurring again, following the completion of this project.

The final outcome:

- 1. The committees would end when the entire network is exposed. After the investigations are completed, those who exposed crime can be employed in roles to prevent it ever happening again.
- 2. This will eventually expose the whole network of criminals and criminal acts and would clean up all of our governmental departments, which are rampant with corruption, fraud, dodgy contracts and, in some cases, what would be classed as terrorist leanings.
- 3. Perpetrators would not go to jail, which will be a relief to them and end some of the fear, but they would be working for the people to investigate and reveal all others in the network. If they hide something and/or fail to fully reveal things, the jail threat and/or the public disgrace of their actions should be a sufficient deterrent.

The whistle-blowers:

- 1. A true whistle-blower protection act should be implemented and enforced, to ensure no intimidation, harassment, or threats can be received by the whistle-blowers or their families.
- 2. Build dedicated new servers and computers to undertake this work, devices that don't have any back doors to the agencies, militaries, third-party subsidiaries, or any other outside threats. These computers can be a side project to eventually replace all computers, laptops, tablets, and phones with technology that has no back doors built in for spying, profiling, advertisements, or mind-control techniques.

To fund this solution:

- 1. Whistle-blowers would be employed by the government in these roles, whose salaries would be cut to a maximum of \$75,000 per year and their pensions drastically reduced, without the government salary/pension for life.
- 2. The government salary/pension-for-life deal needs to be removed from the table once and for all, as a penance for the abuse of office positions. All have gained more than enough during their work time, not taking into account the kickbacks and brown envelopes they have received, and they do not require or warrant those expensive pensions all paid for by the people. The savings from this can go back into the public funds, which can translate to less taxes.
- 3. Remove their security for travel arrangements and any other perks of office.
- 4. Should they be earning \$75,000 a year or more from other ventures, the committee salary would be reduced accordingly. If found that their other income is linked to criminality, it will be seized and put into a fund to improve life here. Preferably the funds should go to our charity, The Peoples Club, as it is our idea and we already have the structure and ideas to take things forward for the benefit of ordinary people. The crimes of these individuals have been perpetrated against the people and the people should gain the benefits, not the lawyers or the malign justice departments.

Benefits to and for the public:

- 1. This drops those who abuse their office down the so-called class scale—no more expensive homes, cars, boats, etc.—and is more in line with the average people. This reduces the gap between the haves and the have-nots and creates a more balanced earnings quota amongst the populace. One hour of their time is equal to one hour of everyone else's time, so why the disparity in earnings? It is not right and creates poverty and poor living conditions for too many. Some will say "You can't expect us to live on a \$75,000 salary." I say you can, if you quit the self-entitlement and greed-based game. Sell your assets and downsize like everyone else. Other solutions we have put forward will put more money in your pockets anyway, so the \$75,000 will be deemed as decent earnings overall. A salary of \$75,000 a year is a gold mine to the vast majority of families and it all comes down to perspective. In reality, socialist lifestyles create mass poverty.
- 2. It will end the fear and blackmail game currently that is holding the old control system together, garnering a more fair and transparent way of operating.
- 3. It will end the repugnant secrecy games that are rampant throughout the corridors of power. It will end the Rothschild and Black Sun groups; it will end the Dragon groups; it will end the lobbyists and terrorist-based organizations like AIPAC that, in part, are responsible for the fear and blackmailing games.
- **4.** The savings for the public will be enormous, plus criminal monies can be added to a People's Fund.
- 5. Taxes will be slashed with a staged reduction of government workers from the current 23.8 million (in the U.S.). It does not require nearly 24 million people to run the government; that is a tragic waste of public funds. The enormous savings of

- wasted taxpayer money spent on spying and surveillance will be a huge boon to the country's finances.
- **6.** It will save on prison costs for these high-profile people. In fact, the salary maximum of \$75,000 a year is less than the cost to house them in prison for most cases. Is it not better that they are employed to clean up their own swamp and do something productive, instead of rotting away in prisons at great cost to the people? This method also reduces the karmic retribution culture, allowing for these people to work on themselves and in some way clear their own karma, which then benefits us all.

Summing up:

How can you help? And what is the Truth, Honour and Integrity Act?

Truth:

- 1. Come forward and expose any and all criminality you are aware of or involved in.
- 2. Expose the masterminds behind the illicit activities.
- 3. Who gave the orders? Who benefited? Which governments/countries/institutions were involved? Which banks or organizations facilitated the operations? Which laws or loopholes were used and how, etc.?
- 4. You will be part of a committee of whistle-blowers and/or previously corrupt officials who come forward. The committees will be a safe environment to expose all relevant details and then work on solutions to right the wrongs and ensure they never happen again.

Honour:

- 1. You will not go to jail; this does not apply to crimes or abuses committed against children.
- 2. You will work for the people and will be compensated for your efforts and contribution, though this will be at levels in line with the pay of ordinary people, not greed-based, high-powered positions.
- 3. For your full disclosure and full cooperation in exposing all the crimes and ills you are aware of or were involved in, you will receive a full pardon.

Integrity:

- 1. The work of the committee will end when the whole network of criminality is exposed, and solutions are identified and put in place to prevent a repeat scenario.
- 2. Depending on the nature and depth or breadth of the area of investigation, the committee's work will generate a significant number of jobs: analysts, researchers, investigators, logistics, security, general office positions, etc.
- 3. Your contribution will benefit society by correcting past mistakes as well as harm and suffering caused, but also, and most importantly to yourself as well, by your own rehabilitation and personal development. We all make mistakes, but we can

also turn these mistakes into lessons by changing our ways, and in doing so we clear our own bad karma and cleanse our souls.

Come forward and speak to us, as together we can make a big difference. We can build a better humanity and a better world for generations to come.

- I am calling on the good people in the government, military, CIA, FBI, NSA, DHS [Canadian CSIS, RCMP] and all other agencies to stand up and expose those criminals in your midst publicly, as silence equals deaths.
- I am calling on the good people in the police to step up and expose those in your midst, as silence equals deaths.
- I am calling on the good people in the military and pentagon [Department of Defence] to step up and expose those in your midst, as silence equals deaths.
- I am calling on the good people in the masons to step up and expose those in your midst, as silence equals deaths.
- I am calling on the good people in universities to expose the agency-based operations in your midst, as silence equals deaths.
- I am calling on people in hospitals, drug manufacturers, and research centres to stand up and speak out now, as silence equals deaths.

Yes, silence does equal deaths and it is your duty and obligation to stand up and speak out. I put myself at risk, the same as many other alt media show hosts, to reveal this criminality each day, so I am not asking you to do anything I haven't done. The Guardians

What is the purpose of this document?

To define in a better, proper, and lawful way under RITA or Universal Law our definitions of man, our status, and declaration of our claim and sovereignty.

Throughout history we have had things determined for us by people with the intent of controlling and enslaving us whilst harvesting our life force energies, with no fair return in exchange. This is essentially classing man as inferior to certain others, when under the guidance of Source we are all born as equals. The claiming of people (and souls) as chattel, with our UN Security cattle code, is a denigration of man, who is denied the true knowledge and meaning of that transaction. Our wealth, which is created at birth, is placed into a fund with a CUSIP number and has been cruelly denied to us by declaring us all dead without our knowledge or consent. This is why they ask us to capitalize our names; notice all headstones are written in the same way. The controllers created then occulted the meaning of words to a level whereby the average man, woman, or child is oblivious to their actual meaning. This is fraud and deception against humanity of the highest order and major corrections have to be made to rectify not only this situation, but the global collapse that is imminent.

Our wealth can never be paid back. We are aware of the total collapse of the old banking systems and how all banks are bankrupt due to the secretive double banking system called the front and back systems. However, the wealth can be paid forward, in a way that is fair and transparent, with the will of people to endeavour that all get as near equal a share as possible. Our solution to fix that is in our New Blueprint For Humanity.

The definitions:

Person:

- A person is a 16th century created word defining a fictional form of property, rights, and title enclosing certain characteristics and appearances as the identity of one or more living men or women.
- 2. A person is formed through the valid entry and registration record on a roll. The highest roll defines the greatest rights for a type of person.
- **3.** The word person comes from the Latin word persona, meaning mask, character, or part of a play.
- 4. The invention of person enabled the enclosure of the bodies of living flesh and the alienation of natural rights associated with them, and viewed them as a type of property which could be sold, purchased, seized, or surrendered.
- **5.** A person may possess greater or lesser authority, powers, and rights than another and a natural man or woman may be associated with more than one person.
- **6.** A person may hold beneficial rights of use, but may not lawfully or legally be the holder of title. As an example, a mortgage deed states that clearly: It reveals you are not the homeowner, but you are a tenant.

- **7.** First person is the highest form of person when they possess the competent mind of a natural living man or woman.
- 8. All-natural living men and women are true persons possessing natural rights associated with a divine trust, when the divine individual spirit conveys these rights on incarnation as a living flesh man or woman with a mind, body, and spirit.
- 9. Failure to recognize a valid, properly constituted and formed person or the claim of superior jurisdiction by an inferior person cannot ecclesiastically, legally, lawfully, or sensibly be sustained without force and coercion; therefore, any subsequent judgement is null and void from the beginning. As well, a natural person attributed to less than a living man or woman or higher order life form is automatically null and void. Attributing a natural or artificial person to an animal, notion, or thing is an unnatural and unlawful act.
- 10.A natural person can never be depreciated to a separate class attributing they possess the lesser form of an animal, and any law, precept, or decree that separates them into a lesser class of animals is automatically null and void from the beginning.

We the people declare our version of people to be the new and lasting version; allnatural living men and women are true persons possessing natural rights associated with a divine trust, when the divine individual spirit conveys these rights on incarnation as a living flesh man or woman with a mind, body, and spirit. All other meanings, definitions, and characterizations placed upon us are null and void.

Subject:

- A subject is a 16th century word describing one who owes their allegiance to a higher office or body politic and accepts the jurisdiction (subject jurisdiction) of their laws.
- The word subject derives from the Latin word subjectio meaning: to submit; to surrender. The word enabled to replace the concept of vassal and serf (slave) into one word.

We the people reject this definition of us being subjects and declare us all as equals.

Citizen and Denizen:

- 1. The terms citizen and denizen are 18th century modified terms defining legal effect of the two possible types of status, title, rights, person, and estate, when the name of a subject or stranger or alien is registered and enumerated:
 - a) A denizen (also listed in the United States since 1790 as a lower-case citizen) is a non-resident alien enfranchised by the sovereign power, retaining full possession of their name, therefore their person and any associated title and derivatives thereof, enabling the enjoyment to rights of property ownership, commerce, and to hold office or dignity. However, a denizen may not inherit lands by descent.

- b) A citizen is a naturalized or natural born resident surrendering ownership of their name; therefore their person or any associated title and derivatives thereof, but granted certain rights and privileges such as right of property ownership, commerce, and to hold certain offices of dignities as well as to inherit the use of lands by descent.
- 2. The original creation of citizen referred to the 14th century members of the Livery Companies in London (known as guilds, such as the BAR Guild today), who were known collectively as the citizens of London.
- 3. The word denizen was originally formed in the 16th century to permit strangers and aliens to acquire property, titles, and official positions in England. The word comes from 2 Latin words: deni, meaning ten or ten times and zona, meaning belt, sash, or girdle; hence, literally meaning: one who possesses ten times the skill (belt, sash, girdle) than a natural born citizen. This enabled the Venetian/Khazar exiles from Pisa and Venice and the "noble" families to become the most influential families in England.
- 4. The first use of citizen in statute was in the 1787 Constitution of the United States, and was in lower case. The creation of upper-case Citizens was through a US Congress Act in 1790 providing for the enumeration of the inhabitants of the United States, which used marshals and militia as well as massive fines and threat of violence to enforce people to register for the census and identify themselves as upper-case Citizens.
- 5. The US Congress Chapter XXXIV, an act making provisions for the payment of the debt of the United States in 1790, then introduced the notion of annuities hidden as bonds and contributors hidden as subscribers against names, lives, and persons listed as upper-case Citizens. The annuities under the guise of bonds were a means of financing such things as war efforts, the accumulating debts of which continue to be passed onto the Citizens themselves.
- **6.** In the 18th century the meaning of citizen and denizen as well as the etymological roots were modified using the Basque language to change the meaning:
 - a) The word citizen was redefined from 2 words: cito (kito) meaning finished, over, terminated and izen, meaning name; hence, Citizen or CITIZEN mean one without ownership or possession of a name, without control of their own estate.
 - b) The word denizen was redefined from 2 words: dena meaning everything, all and izen meaning name; hence, Denizen means one who possesses everything and all associated with the name, without control of their own estate.
- 7. From the early 20th century, a quasi-form of citizen was formed as the CITIZEN or corporate member, equivalent to an upper-case Citizen of a state or country, but for a corporation. This applies to the U.S. government citizenship, as the U.S. government is not a government at all, but a corporation operating as the said government under the auspices of USA Incorporated.
- 8. The legal meaning and application of citizen, Citizen, CITIZEN remains central to the claimed legitimacy of the global bonds, annuities, estates, birth certificates and cestui que vie structure that underpins the hidden model of enslavement of people on behalf of certain private banks.

We the people do not accept roles as denizen or citizen upper or lower case, which was perpetrated by fraud and deceit, and we declare it null and void. We declare and claim our equal rights, annuities, estates, bonds, and birth certificates under the cestui que vie, and demand a proportional share, equal to that of all others.

Resident:

- 1. The word resident is a legal form describing a particular status of a person as bound to certain fiduciary obligations, attached to an office or a dwelling by virtue of occupation, intention, and demonstration of use of such property.
- 2. The word originates from the 16th century from 2 Latin words: res meaning property, thing, object, form, matter and sedere, meaning seat (of office). The word referred to the formalization of benefices, or official estates associated with certain offices of parsons, whereby those appointed to such positions were duty-bound to be present to attend to their duties.
- 3. Resiant, a similar word to resident, was also created in the 17th century as a return to feudal law that bound serfs (slaves) to the lands of their lords, by describing the obligations and benefit of being a tenant-at-will. The concept: that once the tenant accepted the benefit of the tenancy, occupied and used the land, the tenant was obligated to remain on their lot and could not travel without permission from their lord. In other words, they were imprisoned at the behest of the lord.
- 4. In the 18th century, with the replacement of tenancy-at-will with copyhold tenancies, the term resiant was replaced with resident to describe the obligation of tenants to remain on the land of their landlord, subject to the jurisdiction of the law, and not travel unless in possession of a certificate or warrant; this is the origin of the birth certificate.
- **5.** At the same time, landlords and senior officials were granted the description of non-residents, meaning they were not bound to their benefice and could travel freely within certain bounds without need of certificates or permission.

We the people do not accept the role of residents, which was perpetrated by fraud and deceit, and declare it null and void.

Public:

- 1. Public is a 16th century created legal term describing a new form of ownership, rights, and conditions of agreement, whereby true owners are hidden or presumed to be not known, while the community of slaves determines its own affairs as the people or shares power (through parliament) with a ruling class as part of a state.
- 2. The word public is derived from conjoining of the Latin word pube(s), meaning age of majority, young adult, or adult population and liceo, meaning to be for sale, to have a price/value; hence the literal meaning of public is: an adult population for sale. An adult population possessing value as property for community commerce. A self-governing community of hidden commercial slaves.

3. Since the 18th century, the Roman church claim of absolute ownership of all men and women and open slavery was abolished and replaced with the continued and hidden voluntary slavery.

We the people are not public servants or slaves, which was perpetrated by fraud and deceit, and declare it null and void.

Private:

- 1. Private is a 16th century created legal term describing a special and secretive form of ownership, rights, or conditions of agreement or action whereby one or more persons are legally permitted to deprive rights of others.
- 2. The word private is derived from combining the Latin words privo, meaning to deprive, rob, steal, take away, and -atus, a Latin suffix equivalent to -ed in English; hence the literal meaning of private is: legal deprivation, robbing, stealing, or seizure.
- 3. The most common form of the secretive form of private right is called a Letter of Marque. One who holds or possesses a Letter of Marque is normally termed a privateer and one who acts in such a manner without a proper Letter of Marque is called a pirate. The pirates of the seas came onto the land and claimed Maritime Law, in essence.

We the people are not privates, nor do we accept the role of privateers or pirates. We reject the concept of privateers, pirates and letters of marque and all subsequent Maritime law and rules are declared null and void. The claim that some may legally deprive the rights of others or commit theft or unlawful seizure under the term "private" is a violation of true law and is null and void.

State:

A state is a 16th century political term meaning the formal recognition of a country or a territory as a legitimate independent sovereign entity by virtue of an act of recognition by statute from a body politic or another country.

- 1. The word state is derived from the Latin word statuo, connected to the word statute. Hence, a state literally means a body formed through statute.
- 2. A state remains the highest formal recognition of sovereignty.
- 3. A nation cannot formally be recognized as a state. A state subsequently recognized as a nation by definition surrenders its sovereign status as a state in the process.

We the people reject the use of states declared under false premises, and hence, is null and void. We the people wish for the country known as America (not US or U.S.) to be declared as a sovereign nation, with all inhabitants thereof to be of equal rights.

Republic:

- 1. A republic is a 16th century legal term describing an aristocratic form of government which derives all of its power directly or indirectly from the consent of an elite body of members known as the people, in which executive power is lodged in certain offices to which qualified members are then chosen by the general population for a limited period.
- 2. The word republic is derived from the 16th century conjoining of the Latin words res, meaning interest, from affairs, business, matter, wealth; pube(s) meaning age of majority, young adult, or adult population; and liceo, meaning to be for sale, to have a price/value; hence, the literal meaning of republic is community wealth, commonwealth. The concept of commonwealth and republic are one and the same. Which means America is under the jurisdiction of the Commonwealth and a subsidiary of The Crown agents of London, UK.

People:

We the people, not citizens of any form of government, are sovereign people with a free will choice that are not connected or corded to any organization, political or otherwise.

Human:

There are 3 versions of hu-man. The hu in human has three meanings: higher universal; the Sumerian Anunnaki term hu means serpent; in Sanskrit it means dragon. We are defining and declaring our new version as hu meaning higher universal man, not serpent or dragon man. Our freedom to choose what version to be is a universal right, not an Earth-based privilege.

We the people reject all legal terms and their definitions. Legalese means the language of babble or baby talk, and hence, it makes no sense. This means those that operate in it are not of sound mind; they are to be declared incompetent and unable to operate or administer it under natural or RITA law. As sovereign beings and guardians we claim and take full responsibility for the Restoration Plan on behalf of the collective and on behalf of the planet herself until a global referendum can be initiated.

Claim of Title

Before any higher order society, religion, or civilization existed within the star system called the solar system, or any other star system; before the first thoughts, symbols, or words were ever conceived, drawn, or spoken by the ancestors of human beings alive today; and before even life or matter existed, the idea of existence did exist in the form

of that ideal called god (Source), the universal, the absolute, the divine unique collective awareness. It is to this unifying and singular force that the ancestors of human beings alive today directed their invocations. It is this one, true, and absolute divine creator of all existence who bestowed in trust to all living men and women certain irrevocable rights and obligations in perpetual remembrance as trustees and guardians for all life on planet Earth.

Sovereignty

What does it mean to be sovereign, and how do we claim sovereignty? To answer this question, we must define what the original meaning of the word sovereign is, and how ideas in motion (models and systems) influence our ability to be sovereign. Sovereign is an 8th century CE word first defined in Sacre Loi (sacred law of the Carolingians) to describe one anointed by god as having supreme, independent authority to rule a political region known as a realm. The word is derived from the combination of two ancient Latin words: sover meaning saviour, and regno meaning to rule, to be supreme lord. Hence, a sovereign literally means, by its original etymology, to rule and reign as a saviour. Meaning we are our own saviour.

By this definition, any man or woman claiming or appointed to such high office is obligated to the three ancient and primary tasks, being: to protect the realm, protect the law, and protect the people.

- i) To protect and defend a realm is the first obligation of a sovereign as a legally defined entity, defined territory, possessing its own personality and rights.
- **ii)** To protect and defend the law of a realm is the second obligation of a sovereign to ensure rule of law, justice, and equality prevail.
- **iii)**To protect, defend and teach the people of a realm is the third sacred obligation.

To claim oneself sovereign and claim sovereignty of the land we occupy is a tremendous responsibility. It is not something done merely through filing papers or notices through the courts. We first have to be sovereign of spirit, mind, and body. Being sovereign takes knowing you are significant, you are powerful, you have an eternal divine mind/spirit that can never die. That of your own free volition (free will), you accept the obligations that come from accepting the absolute sovereignty of your spirit, mind, and body when claiming the natural rights and rights of use of this planet that were conveyed at birth. Sovereigns are entrusted as guardians to only take what is needed and to look after the planet, as well as our family and community, for current and future generations. It takes living a life of virtue, moral courage, integrity, competence, joy, and compassion, and a will to serve others for the benefit of all.

As we claim our sovereignty, it is helpful to define the models and systems that influence our daily lives and impact our ability to be sovereign. Life is a dream and

dreams have rules; dreams become ideas; ideas become things, models, and systems. The world is full of models and systems that originate with dreams and ideas. A model can be described as an idea in motion. Society operates on manufactured ideas in motion (models and systems). Legal, health, financial, and transport systems etc. abound and are the collection of ideas, originating from many people, that change and adapt over time. This is a natural process.

There have been many corrupt or tyrannical rulers that use these systems to control people and amass wealth and power. There have also been many revolutions and changes in political regimes and rulers when this power is abused. Despite this, despite the many revolutions in the past, we find ourselves even more enslaved today, by regimes in the so-called free world becoming more tyrannical, with power and resources ever more centralized into fewer and fewer hands.

Even when political structures change, the underlying ideas have not changed in over 1,000 years. It doesn't matter how much change occurs at the political level: Until individuals change from the inside and develop better ideas, nothing will truly change. As an example, during the financial collapse in 2008, Henry Paulson said to the politicians, "You may not like the banks; however, keeping the banks alive is the only choice you have. There is no alternative." This was and is the truth.

To be sovereign, we have to change ourselves from within first; for when we change our mind, the whole world changes. We only get as much freedom as we take. We can only be sovereign by being, thinking, and acting different.

We must be sovereign and we must then develop models and systems that enable us to self-sustain, to feed ourselves, maintain our health, and create communities of trust that do not need the models and systems that enslave us. Because we abdicate sovereignty through implied consent when we use the benefits of systems and models provided, as we must also accept the obligations and jurisdiction of these systems when we agree to use them. There is no consent when force and fraud are used. As we work towards being communities of sovereign individuals, we may need to use the current systems out of necessity, meaning we have not given our consent, implied or expressed, as we have been tricked into thinking there are no alternatives.

Sovereignty in the 21st century

There is a long provenance of law, property rights, claims of title, ownership, and possession that is required study to truly grasp how our sovereignty and rights have been enclosed, reducing us to voluntary servitude, known as common law. The brief synopsis in the following paragraphs has a foundation going back many centuries.

In the 21st century, despite all the apparent laws against slavery, land is still defined as any ground, soil, or earth whatsoever, including everything attached to it, whether attached by the course of nature or by the hand of man; thus, this definition considers men and women as legally part of the land as creatures, just as a cow or sheep is. This

then makes them property of the corporations because, by the course of nature, they were born upon the land. Land therefore defines not simply the soil, but all men and women claimed by private corporations registered in Delaware in the United States as part of the global network that usurped constitutions and laws of most western nations using private international law. Despite these outrageous claims, they are still only claims and are only as valid as their provenance.
